residing on the following described territory situated in the
County of Auglaize, and adjacent to the Village of Ordersville,
Ohio, do hereby:

Being a tract of land, said tract being the N.E. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of
the W. $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of section #35, T43-S6E,
Puchanquet Township, Auglaize County, Ohio and being further desc-
ribed as follows:

Beginning at the intersection of the South corporation line
of the Village of Ordersville, Extended, also the North line of
the W. $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of section #35, and the center-
line of Old U.S. Route #25, said point also being the S.E. corner
of the W. $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of section #35; thence
South along the East line of the West $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$
of section #35, said line also being the centerline of Old U.S.
Route #25, to the intersection of the South line of the N.E. $\frac{1}{4}$ of the
W. $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of section #35; thence
West along the South line of the N.E. $\frac{1}{4}$ of the W. $\frac{1}{2}$ of the
of the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of section #35 to the intersection
of said South line and the $\frac{1}{2}$ section line of section #35; thence
North along the $\frac{1}{2}$ section line and the corporation line of the
Village of Ordersville to the intersection of the $\frac{1}{2}$ section line
and the North line of the W. $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of
section #35; thence East along the corporation line of the Village
of Ordersville and the North line of the W. $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ of
the N.E. $\frac{1}{4}$ of section #35 to the place of beginning.

Containing in all 5.00 acres.

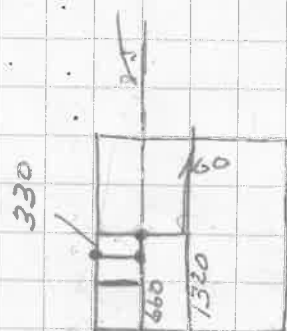
An accurate map of which territory is hereto attached.
