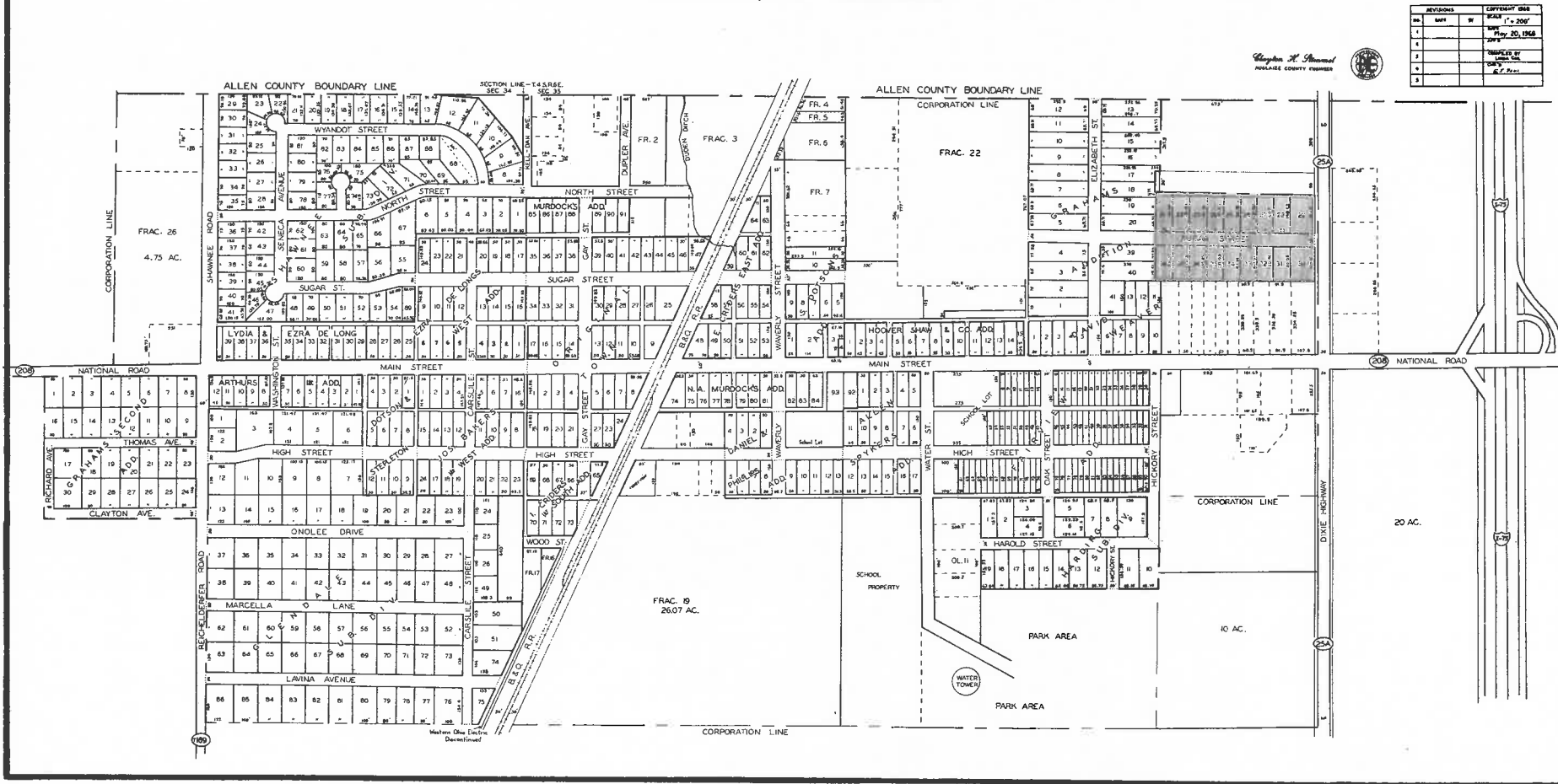

ORDINANCE NO. 1045

TO AUTHORIZE ANNEXATION OF CERTAIN TERRITORY TO THE VILLAGE OF CRIDERSVILLE, OHIO

BE IT ORDAINED, by the Council of the Village of Cridersville, State of Ohio:

Section 1. That the annexation of the following described territory situate in the Township of Duchouquet, County of Auglaize and State of Ohio, to-wit:

Beginning at a point where the east corporation line of the Village of Cridersville intersects the north line of Lot Number 21 in Graham's Addition to Cridersville, Ohio; thence easterly a distance of 643.8 feet, along the north lines of Lots Numbered 21, 22, 23, 24, 25, 26, 27, 28 and 29 of Graham's Addition to said Village to the northeast corner of Lot Number 29 of said Graham's Addition; thence south a distance of 349 feet to the southeast corner of Lot Number 30 in Graham's Addition to said Village; thence westerly a distance of 644.05 feet along the south line of Lots Numbered 30, 31, 32, 33, 34, 35, 36, 37 and 38 to a point where the east corporation line of the Village of Cridersville intersects the south line of Lot Number 38 in Graham's Addition to said Village; thence north along the east corporation line of said Village a distance of 354.86 feet to the place of beginning;

to the Village of Cridersville, Ohio, be and the same is hereby authorized.

Section 2. That the Solicitor be and he is hereby authorized to prosecute the proceedings necessary to effect such annexation.

Section 3. That this Ordinance shall take effect and be in force immediately upon its passage as an emergency measure for the protection of the health, safety and general welfare of the Village of Cridersville and the inhabitants thereof.
