





Situated in the West 1/2 of the Northeast 1/4 of Section 35n, Town l_1 South, Range 6 East, in Duchouquet Township, Auglaize County, Ohio, and adjacent to the Village of Cridersville, being more particularly described as follows:

Beginning at the intersection of the center-line of Main Street in the village of Cridersville and the west right-of-way line of County Road 25A (Dixie Highway), said point being the PLACE OF BEGINNING,

Thence South along the west Right-of-way line of County Road 25A a distance of 556' feet to a point,

Thence West along the existing corporation line a distance of 645' feet to a point in the North/South corporation line,

Thence South along the corporation line a total distance of 1717' feet to a point,

Thence East, passing through the centerline of County Road 25A at 692' feet and also passing through the West Right-of-way line of Interstate 75 at 1312', a total distance of 1412' feet to the centerline of Interstate 75,

Thence north along the centerline of Interstate 75 a distance of 2273' feet to a point at the intersection of Interstate 75 and County Road 208 (National Road),

Thence West along the centerline of County Road 20% a distance of 765' feet to the PLACE OF BEGINNING.

The above tract of land contains 65.42 acres.

Thence west along the existing corporation line a distance of 645' (feet) to a point in the North/South corporation line.

Thence south along the corporation line a total distance of 1717 (feet) to a point.

Thence East, passing through the centerline of county road 25-A at 692' (feet) and also passing through the West right-of-way line of Interstate 75 at 1312' (feet) a total distance of 1412' (feet) to the centerline of Interstate 75

Thence north along the centerline of Interstate 75 a distance of 2273' (feet) to a point at the intersection of Interstate 75 and county road 208 (National Road)

Thence west along the centerline of county road 208 a distance of 705 (feet) to the PLACE OF BEGINNING.
