## PETITION TO VACATE STREET AND ALLEY

To The Auglaize County Board of County Commissioners Gentlemen:

The undersigned hereby represent to the Board of Commissioners of Auglaize County, Ohio, that they are the owners of the right to mine coal lying adjacent to the street and alley hereinafter described and further are the owners of the real estate abutting the street and alley hereinafter described. The undersigned represent to the Board of County Commissioners that a public road and alley was once established by Plat, that further that this road and alley has not been improved by public funds and for more than twenty-one years has not been used.

The undersigned, in accordance with Revised Code Sections 5553.23, 5553.042, and 5553.04 through 5553.11 respectfully request that the Board vacate the following described alley and street:

Situated in the Village of Fryburg, Township of Pusheta, County of Auglaize and State of Ohio, and more particularly bounded and described as follows:

Beginning at the Northeast corner of Lot Number Fifty of P. Wagner's Second Addition; thence South along the East line of Lots Number Fifty and Fifty-One to the Southeast corner of Lot Number Fifty-One of P. Wagner's Second Addition; thence East to a point in the West line of Lot Number Fifty-Two of P. Wagner's Second Addition; thence North along the West line of Lot Number Fifty-Two of P. Wagner's Second Addition to the Northwest corner of said Lot Number Fifty-Two; thence East along the North line of Lots Number Fifty-Two and Fifty-Three of P. Wagner's Addition to a point on the North line of said Lot Number Fifty-Three, said point being twelve feet West of the point where the East line of Lot Number Forty-Eight of P. Wagner's Second Addition, extended, intersects the North line of Lot Number Fifty-Three; thence North to a point in the South line of Lot Number Forty-Eight of P. Wagner's Second Addition, said point being twelve feet West of the Southeast corner of said Lot Number Forty-Eight; thence West along the South lines of Lots Number Forty-Eight and Forty-Nine of P. Wagner's Second Addition to the Southwest corner of said Lot Number Forty-Nine; thence North along the West line of said Lot Number Forty-Nine to the Northwest corner of said Lot Number Forty-Nine; thence West, forty-nine and 5 tenths feet, more or less, to the point of beginning.

Attached hereto as Exhibit A is a copy of the Plat showing the portion of the street and alley proposed to be vacated. The undersigned represent that neither the alley nor the street has been improved, maintained, nor used, for a period of an excess of twenty-one years and that they are entitled to have the same vacated. The undersigned further agree to be responsible for the costs and expenses incurred by the Board in
