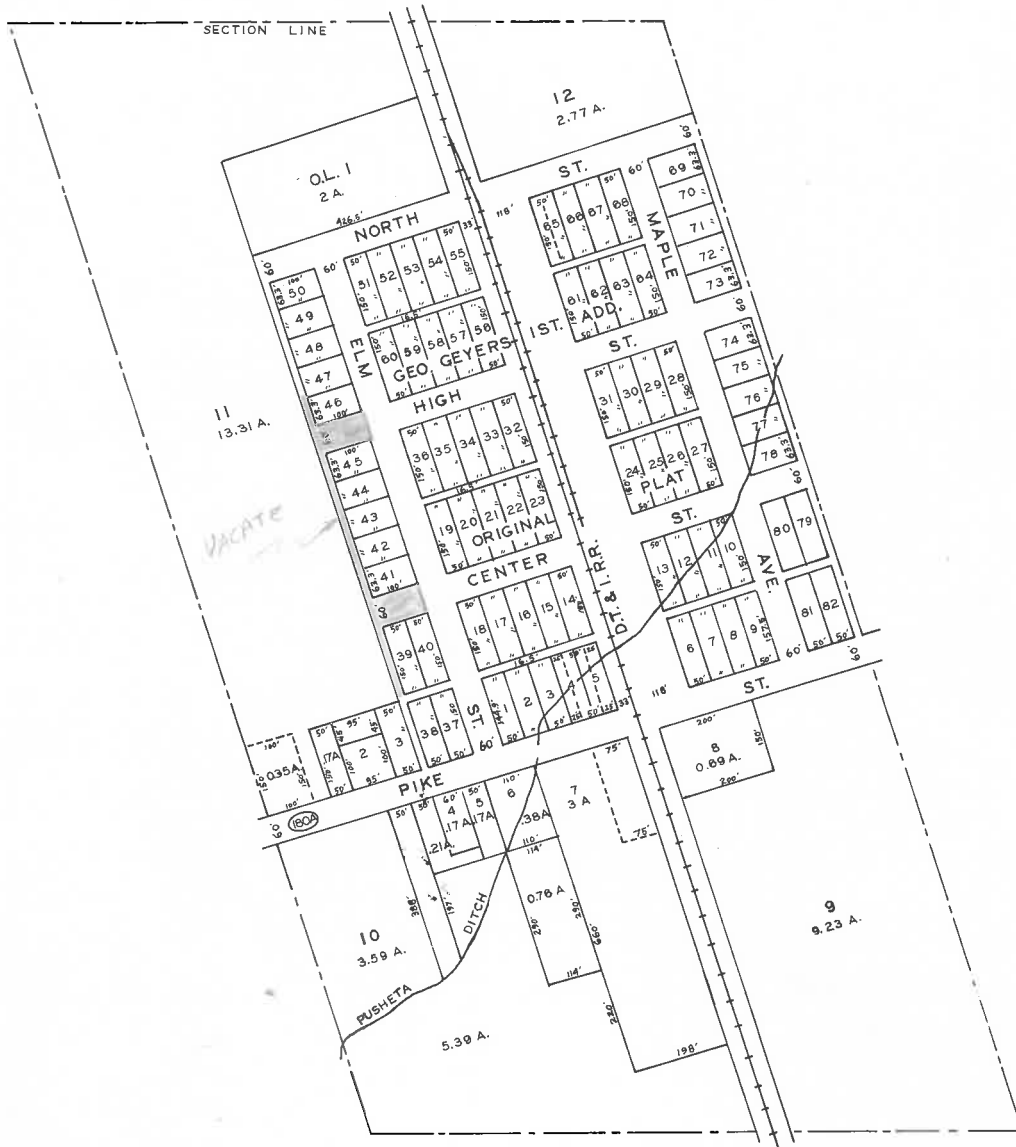


Gentlemen:
