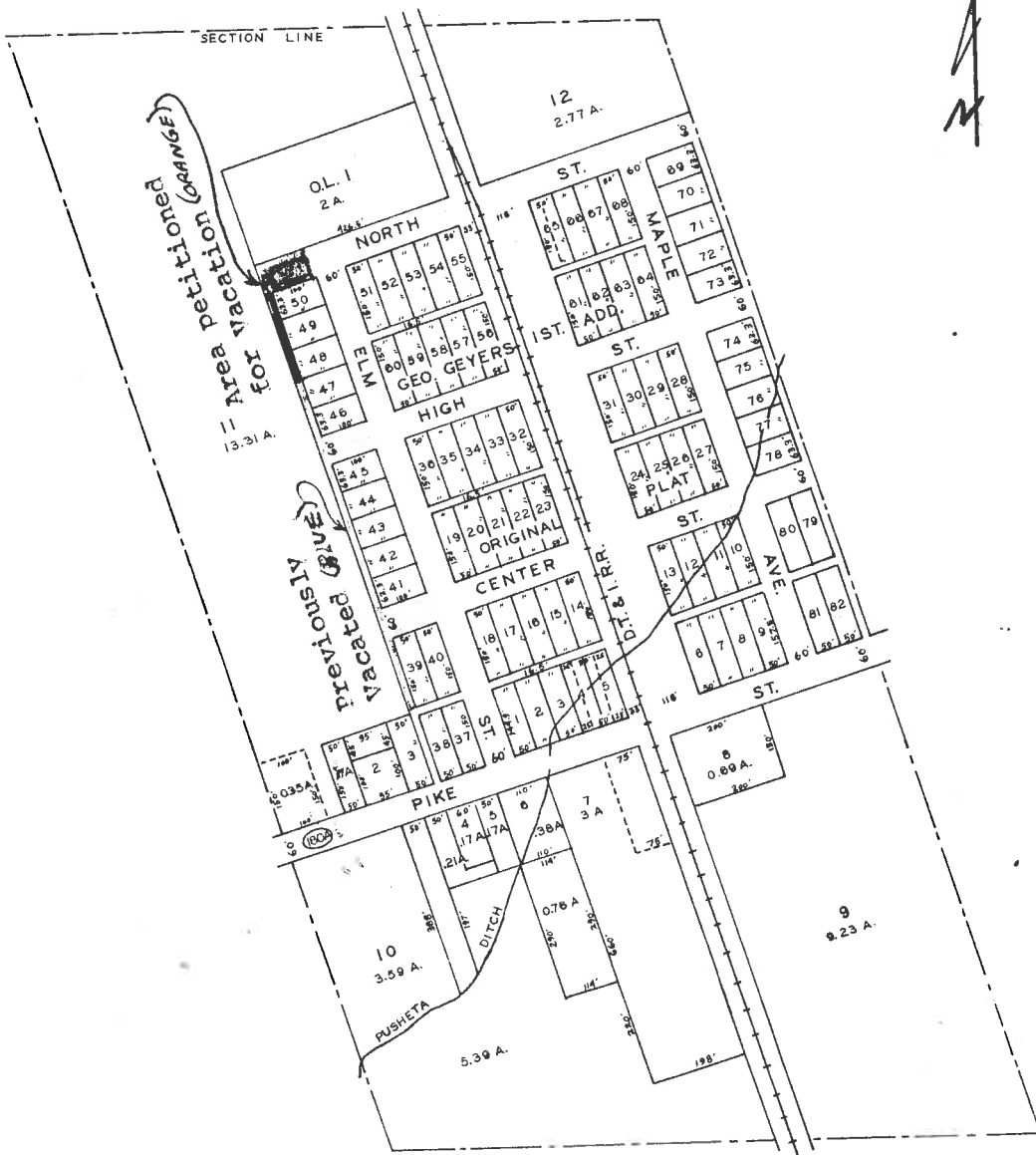

This being the date set in its order of April 3rd, 1986, with proper legal advertisement  
having been made by the Clerk of the Board of Auglaize County Commissioners,  
said Board did hold a public hearing on the alley vacation petitioned by Ina Pratt.

A view of the section of alley to be vacated in the unincorporated Village of Geyer  
was made by the Board of County Commissioners on April 24, 1986 as previously  
ordered.

vacation request. The Clay Township Trustees were contacted inregards to their

own expense.

# PUBLIC ROAD PETITION

To the Honorable Board of County Commissioners of

The undersigned petitioners, freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience and welfare require the <sup>1</sup> vacating of <sup>2</sup> a Public Road on the line hereinafter described; and make application to you to institute and order proper proceedings in the premises, for <sup>1</sup> vacating such road; the same <sup>not</sup> being a road on the State Highway System. (not)

The following is the general route and termini of said road:

Beginning at <sup>4</sup> the SW corner of Lot 48 in George Geyer's First Addition, Village of Geyer, Clay Township, Auglaize County, State of Ohio, thence in a northwesterly direction along the west boundary lines of Lots 48, 49 and 50, a total distance of 189.2 feet and a width of 18.5 feet, thence in a northeasterly direction along the north boundary line of Lot 50 a total distance of 100 feet and a width of 60 feet to the NE corner of Lot 50.
