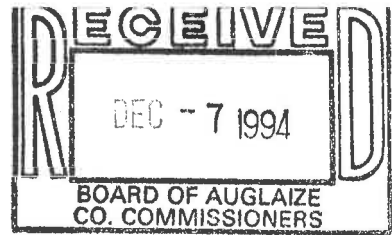

PETITION TO VACATE STREET

To: The Board of Commissioners of Auglaize County, Ohio

Gentlemen:

The undersigned hereby represents to the Board of Commissioners of Auglaize County, Ohio that they are the owners of the real estate abutting the streets and alleys hereinafter described. The undersigned further represents to the Board of Commissioners of Auglaize County, Ohio that public streets and alleys were once established by plat, that said streets and alleys have not been improved by public funds, and that for more than 21 years said streets and alleys have not been used.

The undersigned in accordance with Ohio Revised Codes Sections 5553.23, 5553.042, and 5553.04-5553.11, respectfully requests that the Board vacate the following described streets and alleys:

All of Elm Street in the Village of Kossuth as lies south of Main Street to Walnut Street. The alleys from the Miami and Erie Canal, in Kossuth to Ash Street, lying south of Main Street, and the alley from Main Street to Walnut Street, lying between Elm Street and Ash Street.

Attached hereto and marked as Exhibit "A" is a copy of a plat showing the portions of said street proposed to be vacated.

The undersigned represents that the street and alleys have not been improved, maintained, nor used for a period of in excess of 21 years and that they are entitled to have the same vacated.

The undersigned further agrees to be responsible for the costs and expenses incurred by the Board of Commissioners in connection with these proceedings and agrees to furnish a bond if required by the Board to secure the payment of such costs and expenses or, in the alternative, to submit a deposit requested by the Board of County Commissioners of Auglaize County, Ohio.
