RESOLUTION OF COUNTY COMMISSIONERS
APPROVING ANNEXATION

Pursuant to a resolution adopted by the Board of County Commissioners on the 13 day of MARCH, 1984, fixing the 29 day of MAY, 1984, for hearing the petition praying for the annexation of certain territory in Jackson Township, Auglaize County, Ohio, to the Village of Minster, Auglaize County, Ohio, the same came on for hearing and all persons appearing for or against the annexation were heard, received, and the Board of County Commissioners finds as follows:

1. The petition contains all matters required by law including, without limitation, Revised Code §709.02, to wit:
 - a. A full description and accurate map or plat of the territory sought to be annexed;
 - b. A statement of the total number of owners of real estate in the territory sought to be annexed;
 - c. The name of the person to act as agent for the petitioners.
2. The matters alleged in the petition are true.
3. Notice of the petition has been published as required by law, and all notices of filing the petition and the hearings thereon have been given and delivered as required by law.
4. The persons whose names are subscribed to the petition are owners of real estate in the territory described in the petition, and as of the time the petition was filed, the number of valid signatures on the petition constituted a majority of the owners of real estate in

the territory proposed to be annexed. None of the signatures have been withdrawn pursuant to Ohio Revised Code §709.03 or §709.032.

5. The territory included in the annexation petition is not unreasonably large.

6. The territory proposed for annexation is adjacent to the Village of Minster, Ohio.

7. The map or plat and the description of the territory contained in the petition are accurate.

8. The general good of the territory sought to be annexed will be served if the annexation petition is granted and the annexation is allowed.

It is therefore ordered that the prayer of the petition be and it is hereby granted and that the territory described in the petition be annexed to the Village of Minster, Ohio. It is further ordered that the final transcript of this Board relating thereto, together with the accompanying map and petition and all other papers pertaining thereto, be delivered forthwith to the Clerk of Council, Village of Minster, Ohio.

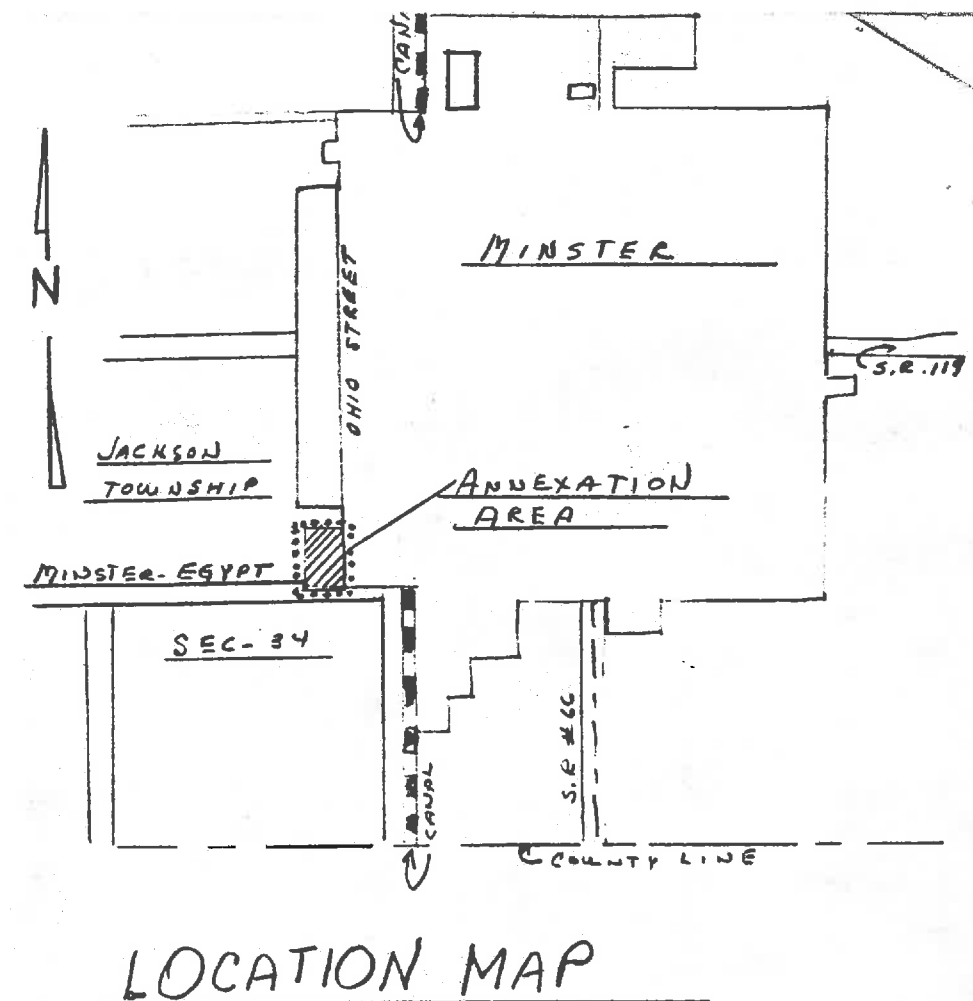
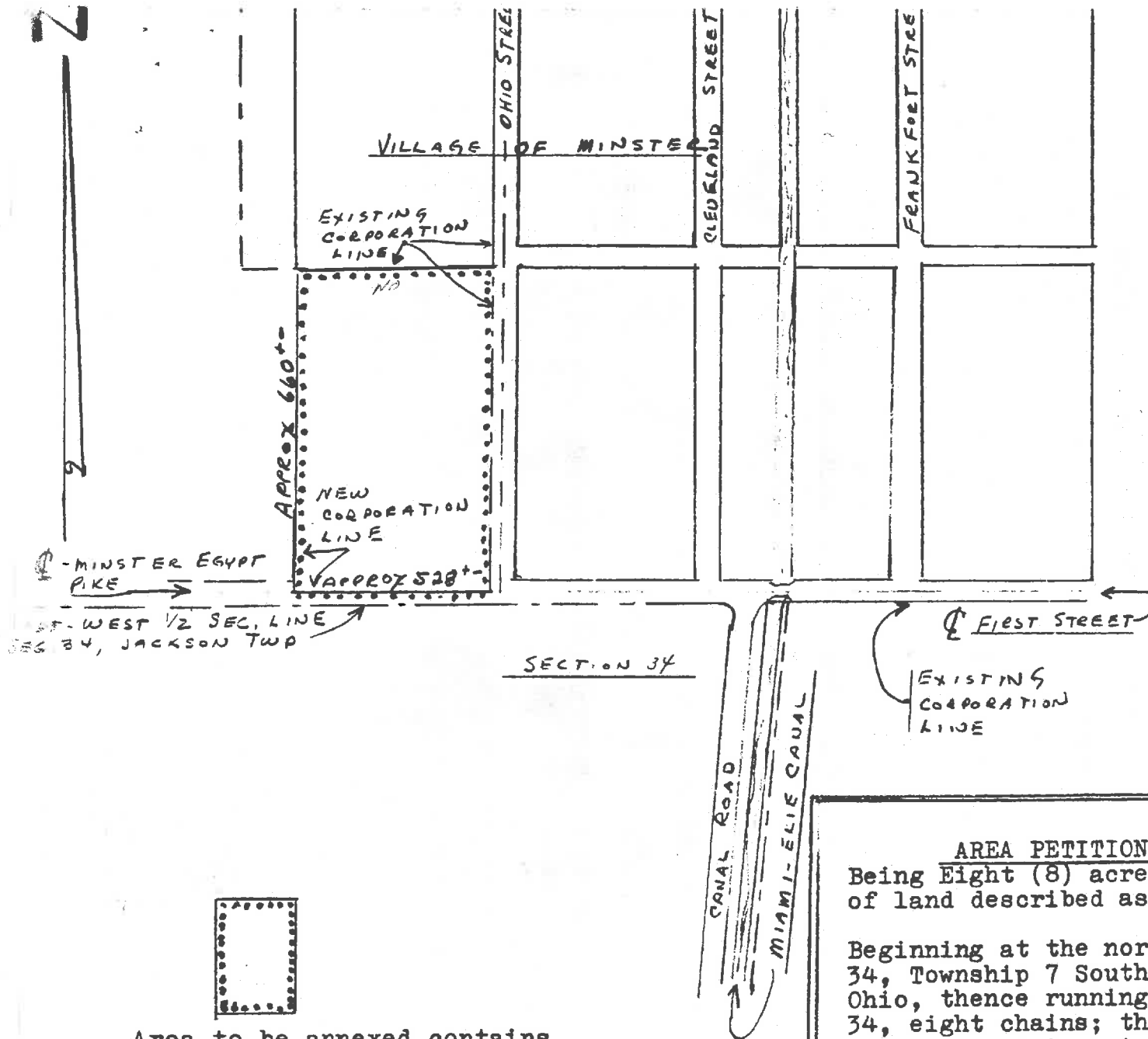

EXHIBIT "A"

ORDINANCE NO. 1984-8-2

AN ORDINANCE ANNEXING A CERTAIN TERRITORY CONTAINING
8 ACRES, MORE OR LESS, IN JACKSON TOWNSHIP
TO THE VILLAGE OF MINSTER

WHEREAS, a petition for the annexation of certain territory in Jackson Township was duly filed by the owners thereof, and

WHEREAS, the petition was duly considered by the Board of County Commissioners of Auglaize County, Ohio, on the 29th day of May, 1984, and

WHEREAS, the Board of County Commissioners has approved the annexation of the territory to the Village of Minster, Ohio, as hereinafter described, and

WHEREAS, the Board of County Commissioners certified the transcript of the proceedings in connection with the annexation with the map and petition required in connection therewith to the Clerk of Council, who received the same on the 4th day of June, 1984, and

WHEREAS, sixty days from the date of the filing have now elapsed in accordance with the provisions of Ohio Revised Code Section 709.04;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL FOR THE VILLAGE OF MINSTER, OHIO:

SECTION 1. That the proposed annexation as applied for in the petition of a majority of the owners of real estate in the territory sought to be annexed, and filed with the Board of County Commissioners of Auglaize County, Ohio, on the 12th day of March, 1984, and which petition prayed for annexation to the Village of Minster, Ohio, of certain territory adjacent thereto as hereinafter described and which petition was approved for annexation to the Village of Minster by the Board of County Commissioners on the 29th day of May, 1984, be and the same is hereby accepted. A legal description of the territory is attached hereto as Exhibit A. - map.

The certified transcript of the proceeding for annexation with an accurate map of the territory, together with the petition for its annexation, and other papers relating to the proceedings thereto of the County Commissioners are all on file with the Clerk of Council of the Village of Minster, and have been on file for more than sixty days.

SECTION 2. That the Clerk of Council be and he is hereby authorized and directed to make three copies of this ordinance to each of which shall be attached a copy of the map accompanying the petition for annexation, a copy of the transcript of the proceedings of the Board of County Commissioners relating thereto, and a certificate as to the correctness thereof. The Clerk shall then forthwith deliver one copy to the County Auditor, one copy to the County Recorder, and one copy to the Secretary of State and shall file notice of this annexation with the Board of Elections within thirty days after it becomes effective, and the Clerk shall do all other things required by law.

SECTION 3. This ordinance shall take effect at the earliest date provided by law.
