

ORDINANCE NO. 1963 - 28

ORDINANCE TO VACATE THAT PART OF FIFTH STREET BETWEEN CLEVELAND STREET AND OHIO STREET IN THE VILLAGE OF MINSTER, OHIO, WHICH LIES EAST OF THE ALLEY LYING MIDWAY BETWEEN CLEVELAND STREET AND OHIO STREET AND WHICH LIES 56 FEET WEST OF THE WEST SIDE OF CLEVELAND STREET, BEING BORDERED ON THE WEST BY THE AFOREMENTIONED ALLEY PARALLEL CLEVELAND STREET AND ON THE EAST BY A LINE PARALLEL WITH AND 56 FEET WEST OF THE WEST LINE OF CLEVELAND STREET AND BEING APPROXIMATELY 162.75 FEET LONG AND 50 FEET WIDE AND TO DECLARE AN EMERGENCY

WHEREAS, on the 19th day of November, 1963, a petition by persons owning lots in the immediate vicinity of that part of Fifth Street between Cleveland Street and Ohio Street in the Village of Minster, Ohio, which lies east of the alley lying midway between Cleveland Street and Ohio Street and which lies 56 feet west of the west side of Cleveland Street, being bordered on the west by the aforementioned alley parallel Cleveland Street and on the east by a line parallel with and 56 feet west of the west line of Cleveland Street and being approximately 162.75 feet long and 50 feet wide was duly presented to council praying that said street, between the points named, be vacated; and whereas a written consent to such vacation was filed with the legislative authority by the owners of the property abutting the part of the street or alley proposed to be vacated; and

WHEREAS, council upon hearing, is satisfied that there is good cause for such vacation as prayed for, that it will not be detrimental to the general interest, and ought to be made, now therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MINSTER, OHIO, STATE OF OHIO:

Section 1: That Fifth Street between Cleveland Street and Ohio Street in the Village of Minster, Ohio, which lies east of the alley lying midway between Cleveland Street and Ohio Street and which lies 56 feet west of the west side of Cleveland Street, being bordered on the west by the aforementioned alley parallel Cleveland Street and on the east by a line parallel with and 56 feet west of the west line of Cleveland Street and being approximately 162.75 feet long and 50 feet wide be and the same is hereby vacated.

Section 2: That this ordinance be an emergency ordinance because of the need to vacate this street as soon as possible and that it remain in force from and after the earliest period allowed by law.
