

ORDINANCE NO. 1963 - 28

ORDINANCE TO VACATE THAT PART OF FIFTH STREET BETWEEN CLEVELAND STREET AND OHIO STREET BEING THE SOUTH HALF OF THE EAST 56 FEET OF THAT PART OF FIFTH STREET THAT LIES BETWEEN CLEVELAND STREET AND OHIO STREET IN THE VILLAGE OF MINSTER, OHIO, AND TO DECLARE AN EMERGENCY

WHEREAS, on the 15th day of November, 1963, a petition by persons owning lots in the immediate vicinity of that part of Fifth Street between Cleveland Street and Ohio Street beginning at the northeast corner of Block "I" of Lot 48, being also the southwest corner of the intersection of Cleveland and Fifth Street; thence west along the south line of Fifth Street a distance of 56 feet; thence north 25 feet to the centerline of Fifth Street; thence east 56 feet to the west line of Cleveland Street; thence south 25 feet to the place of beginning, being the south half of the east 56 feet of that part of Fifth Street that lies between Cleveland and Ohio Street in the Village of Minster, Ohio, was duly presented to council praying that said street, between the points named, be vacated; and whereas a written consent to such vacation was filed with the legislative authority by the owners of the property abutting the part of the street or alley proposed to be vacated; and

WHEREAS, council upon hearing, is satisfied that there is good cause for such vacation as prayed for, that it will not be detrimental to the general interest, and ought to be made, now therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MINSTER, OHIO, STATE OF OHIO:

Section 1. That Fifth Street from that part of Fifth Street between Cleveland Street and Ohio Street beginning at the northeast corner of Block "I" of Lot 48, being also the southwest corner of the intersection of Cleveland and Fifth Street; thence west along the south line of Fifth Street a distance of 56 feet; thence north 25 feet to the centerline of Fifth Street; thence east 56 feet to the west line of Cleveland Street; thence south 25 feet to the place of beginning, being the south half of the east 56 feet of that part of Fifth Street that lies between Cleveland and Ohio Street in the Village of Minster, Ohio, be and the same is hereby vacated.

Section 2. That this ordinance be an emergency ordinance because of the need to vacate this street as soon as possible and that it remain in force from and after the earliest period allowed by law.
