

ORDINANCE NUMBER 73-7-1

TO VACATE AN ALLEY LYING BETWEEN LOTS FORTY-NINE (49), FIFTY (50), FIFTY-ONE (51) AND FIFTY-TWO (52), BLOCK "C", AND LOTS FORTY-NINE (49), FIFTY (50), FIFTY-ONE (51) AND FIFTY-TWO (52) OF BLOCK "D" BETWEEN THE NORTH LINE OF FIFTH STREET AND THE SOUTH LINE OF LOT NUMBER FOUR (4) OF JOSEPH MELCHER'S SUBDIVISION IN SAID VILLAGE

WHEREAS, on the 17th day of July, 1973 a petition by persons owning lots in the immediate vicinity of an alley lying between lots Forty-nine (49), Fifty (50), Fifty-one (51) and Fifty-two (52) of Block "C" and Lots Forty-nine (49), Fifty (50), Fifty-one (51) and Fifty-two (52) of Block "D" from the north line of Fifth Street to the south line of Lot Number Four (4) of Joseph Melcher's Subdivision in the Village of Minster, Ohio, was duly presented to Council praying that said alley, between the points named, be vacated; and

WHEREAS, all of the owners of property abutting the part of the alley proposed to be vacated have filed with the Council their written consent to such vacation and notice of pendency and prayer of the petition to vacate is therefore not required, and

WHEREAS, Council, upon hearing, is satisfied that there is good cause for such vacation as prayed for, that it will not be detrimental to the general interest, and ought to be made, NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MINSTER, STATE OF OHIO:

SECTION 1: That the alley lying between Lots Forty-nine (49), Fifty (50), Fifty-one (51) and Fifty-two (52) of Block "C" and Lots Forty-nine (49), Fifty (50), Fifty-one (51) and Fifty-two (52) of Block "D" from the north line of Fifth Street to the south line of Lot Number Four (4) of Joseph Melcher's Subdivision in the Village of Minster, be and the same is hereby vacated.

SECTION 2: That this Ordinance be and remain in full force from and after the earliest period allowed by law.
