Notice is hereby given that on the 3rd day of September, 1957 there was presented to the Board of Commissioners of the County of Auglaize, State of Ohio, a petition from the Council of the Village of New Bremen, Ohio, pertaining to the annexation of the following described territory situated in the county of Auglaize and adjacent to the Village of New Bremen, to wit:

Beginning at the intersection of the centerline of East Monroe Street (also State Route 274 and the south line of Section 11, German Township, Auglaize County, Ohio) and the east corporation line of the Village of New Bremen, Ohio. Thence east following the center line of said State Route 274 a distance of 667.1 feet to a point; thence north, parallel the east corporation line of the Village of New Bremen a distance of 947.3 feet; thence west parallel the centerline of State Route 274 a distance of 657.1 feet, more or less to the centerline of a stream, this centerline being ten feet, more or less, east of the east corporation line of said Village of New Bremen; thence south on this centerline of the stream for a distance of 191.3 feet; thence west to the corporation line, a distance of ten feet, more or less, thence south on the present corporation line of the Village of New Bremen for a distance of 756 feet to the point of beginning.

PETITION TO COUNTY COMMISSIONERS

To the Commissioners of Auglaize County, State of Ohio:

The Village of New Bremen respectfully represents that by an Ordinance duly passed by its Council on the 6th day of August, 1957, the following described territory was authorized to be annexed to said village, to wit:

Beginning at the intersection of the centerline of East Monroe Street (also State Route 274 and the South line of Section 11- German Township, Auglaize County) and the east corporation line of the Villate of New Bremen, Ohio. Thence East following the centerline of said State Route 274 a distance of 667.1 feet to a point; thence north; parallel the East corporation line of the Village of New Bremen; a distance of 947.3 feet; thence West parallel the centerline of State Route 274 a distance of 657.1 feet, more or less, to the centerline of a stream; this centerline being ten feet, more or less, East of the East corporation line of said village of New Bremen; thence South on this centerline of the stream for a distance of 191.3 feet; thence West to the corporation line a distance of ten feet, more or less, thence South on the present corporation line of the Village of New Bremen for a distance of 756 feet to the point of beginning, containing in all 15.12 acres, more or less.
