

ORDINANCE NO. 923

AN ORDINANCE TO VACATE AN ALLEY LYING BETWEEN HERMAN AND FRANKLIN STREETS, AND PARALLEL TO AND BETWEEN VOGELSANG AND POPLAR STREETS IN THE VILLAGE OF NEW BREMEN.

WHEREAS, on the 7th day of July, 1942 a petition by all of the persons or parties owning lots in the immediate vicinity of the alley hereinafter described, was duly presented to the council, praying that said alley be vacated; and it further appearing that notice by publication is not required insofar as all of the abutting property owners have signed said petition as provided by General Code 3727, and,

WHEREAS, council upon hearing is satisfied that there is good cause for such vacation as prayed for, that it will not be detrimental to the general interests and ought to be made, no therefore,

BE IT ORDAINED by the council of the Village of New Bremen, Auglaize County, Ohio:

SECTION 1. That the alley described as follows, to-wit:

Situate in the Village of New Bremen, County of Auglaize, State of Ohio, and being an alley running east and west lying parallel to and between Vogelsang Street and Poplar Street in said Village, and extending west from Franklin Street to Herman Street,

be and the same is hereby vacated.

SECTION 2. That the ordinance be and remain in force from and after the earliest period allowed by law.

RESOLUTION NO. 125

A RESOLUTION DIRECTING AND AUTHORIZING THE PRESIDENT AND CLERK OF THE BOARD OF EDUCATION TO EXECUTE A PETITION FOR THE VACATION OF CERTAIN PUBLIC LANDS.

WHEREAS, adjacent property owners have prepared and executed a petition for the vacation of the following described land, to-wit:

Situate in the Village of New Bremen, County of Auglaize, State of Ohio, and being an alley running east and west lying parallel to and between Vegelsang Street and Poplar Street in said village, and extending west from Franklin Street to Harman Street, and,

WHEREAS, it would promote safety and protection of school children by removing a traffic hazard to vacate said public land, now therefore,

BE IT RESOLVED by the Board of Education of the Village of New Bremen, Auglaize County, Ohio:

SECTION 1. That it is deemed necessary and for the protection and safety of school children, that the above described land be vacated.

SECTION 2. That the president and clerk of the Board of Education be, and they are hereby authorized, to execute a petition to be filed with the council of the Village of New Bremen, Auglaize County, Ohio, requesting said premises be vacated.
