


ORDINANCE NO. 2193AN ORDINANCE AUTHORIZING THE ANNEXATION OF CERTAIN
TERRITORY TO THE CITY OF ST. MARYS, OHIO.NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL FOR THE CITY OF ST.
MARYS, OHIO:SECTION 1. That the annexation of the following described property situated
in the S 1/2 of Section 10, St. Marys Township T6S, RAE with respect to the First
Principal Meridian, Auglaize County, Ohio,

Commencing at Station 547 +78 in the centerline of S.R. 66 thence S. 67° 30' W, for a distance of 60.27 feet along the centerline of newly constructed County Road 66A to a point in the west right-of-way of S.R. 66, said point being the place of beginning; thence S. 27° 16' E. along the west right-of-way line of S.R. 66 a distance of 54.34 feet to an iron pin; thence S 81° 58' W. for a distance of 96.50 feet to an iron pin; thence S. 67° 30' W. along the south right-of-way of County Road 66A for a distance of 275.26 feet to a point; thence southerly at an interior angle of 70° 02' for a distance of 480.28 feet to an iron point; thence southwesterly at an interior angle of 118° 00', a distance of 136.18 feet to a point; thence at an interior angle of 150° 03', a distance of 635.25 feet to a point; thence southerly at an interior angle of 269° 46', a distance of 246.95 feet to a point; thence southwesterly at an interior angle of 153° 15', a distance of 311.18 feet to a point; thence at an interior angle of 118° 41', a distance of 722.90 feet to a point; thence northerly at an interior angle of 101° 38', a distance of 208.03 feet; thence westerly at an interior angle of 270° 00', a distance of 217 feet, said point being the westerly right-of-way line of Route 66A as it traverses generally north and south; thence northerly along the westerly right-of-way line of County Road 66A, a distance of 632 feet with said line intersecting with the southern boundary line of the corporation limit of the City of St. Marys; thence easterly along said corporation line to a point of intersection with the easterly right-of-way line of County Road 66A, said east and west line following the south corporation line of St. Marys; thence southerly along the easterly right-of-way line of County Road 66A, to a point in the south right-of-way line of the Miami and Erie Feeder Canal; thence easterly along the south right-of-way line of the Miami and Erie Feeder Canal right-of-way line to a point where it intersects the west right-of-way line of S.R. 66; thence S. 27° 31' E. along the west right-of-way line of S.R. 66 for a distance of 84.71 feet to the point in the centerline of the constructed County Road 66A which was the place of beginning.

to the City of St. Marys, be and is hereby authorized and accepted.

SECTION 2. That an accurate map of the territory together with the petition
for its annexation and other papers relating thereto and a certified transcript of
the proceedings of the County Commissioners in relation thereto are on file with
the Clerk of the Council of said City, and all proceedings thereunder together
with the map and other papers are hereby accepted.SECTION 3. That this ordinance shall be in force and take effect at the
earliest possible date provided by law.Passed this 26th day of February, 1968.
