ORDINANCE NO. 1667

TO VACATE A PART OF EAST SOUTH STREET BEING A STRIP OF LAND EIGHT FEET WIDE AND NINETYSEVEN FEET LONG LYING ADJACENT TO AND SOUTH OF LOT NUMBER ONE OF BLOCK NUMBER THIRTY-ONE
IN THE EAST ADDITION TO THE CITY OF ST. MARYS, OHIO.

WHEREAS, on the 24th day of June, 1957, Clara E. Grider, the owner of Lots Numbered One and Two in Block Number Thirty-one in the East Addition to the City of St. Marys, Ohio, filed her Petition requesting the vacation of a part of East South Street being a strip of land eight feet wide and ninety-seven feet long lying adjacent to and southerly of Lot Number One in Block Number Thirty-one in the East Addition to the City of St. Marys, Ohio; and,

WHEREAS, the vacation of said strip of land would reduce a hazard that presently exists; and,

WHEREAS, the Petitioner has agreed to improve and maintain a sufficient thoroughfare for pedestrians across said property to be vacated; and,

WHEREAS, the Council of the City of St. Marys, Ohio, is satisfied that there is good cause for such vacation as prayed for and it will not be detrimental to the general interest and ought to be made. Now Therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ST. MARYS, OHIO:

SECTION ONE: That the following described real estate be and the same hereby is vacated, to-wit:

Being a tract of land and a part of East South Street that lies South of Lot Number One (1) in Block Number Thirty-one (31) in the East Addition to the City of St. Marys, County of Auglaize and State of Ohio, to-wit:

Beginning at an iron pin in the Southwest corner of Lot Number One (1) in Block Number Thirty-one (31) of the East Addition to the City of St. Marys, Ohio; thence continuing in a Southeasterly direction on a line being the West line of said Lot Number One (1) extended for a distance of eight (8) feet; thence in an easterly direction on a line parallel to the South line of said Lot Number One (1), a distance of Ninety-seven (97) feet; thence Northwesterly a distance of eight (8) feet to the Southeast corner of said Lot Number One (1); thence along the South line of said Lot Number One (1) a distance of Ninety-seven (97) feet to the place of beginning. The real estate above described being a rectangular tract of land eight (8) feet by Ninety-seven (97) feet being southerly of and adjacent to said Lot Number One (1) in Block Number Thirty-one (31) in the East Addition to the City of St. Marys, Ohio.

SECTION TWO: This is an emergency ordinance. The reason for the emergency lies in the fact that the definite boundaries and areas of the streets of the City of St. Marys, should be specifically delineated and that it is necessary to preserve the streets in this exact prescribed area which is vital and necessary to the welfare of the citizens of the City of St. Marys, Ohio.
