## BILL OF SALE.

KNOW ALL MEN BY THESE PRESENTS, that OHIO POWER COMPANY, an Ohio corporation, for the consideration of One Dollar (\$1.00) and other valuable considerations, received to its full satisfaction of THE DAYTON POWER AND LIGHT COMPANY, an Ohio corporation, does hereby sell, transfer and deliver unto said THE DAYTON POWER AND LIGHT COMPANY, its successors and assigns forever, the following described goods and chattels:

All the poles, wires, cables, anchors, fixtures and other attachments constituting the electric transmission line now owned by Ohio Power Company and located in St. Marys Township and in the City of St. Marys, Auglaize County, Ohio, beginning as a double-circuit line at the town-ship line between Section 6 of Washington Town-ship and Section 1 of St. Marys Township, and extending thence in a westerly direction to the eastern corporation limits of the City of St. Marys, and there dividing into two separate lines, one continuting in a westerly and southwesterly direction through the City of St. Marys, and the other in a southerly and then a westerly direction, both to a terminal point at the former electric generating station of Central Ohio Light & Power Company in the City of St. Marys, but excepting the first three pole structures immediately west of the Township line, with the wires extending to but not beyond the third pole, and all anchors, fixtures and attachments thereto.

TO HAVE AND TO HOLD the said goods and chattels unto the said THE DAYTON POWER AND LIGHT COMPANY, its successors and assigns forever.
