AN ORDINANCE TO AUTHORIZE THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF ST. MARYS. OHIO.

RE IT ORDAINED BY THE COUNCIL FOR THE CITY OF ST. MARYS, OHIO:
SECTION 1. That the annexation of the following described territory:

All that part of the following described territory that lies:
in Section Four (4), St. Marys Township, said entire tract being
Seventeen and Fifty-five Hundredths (17.55) acres, more or less,
located in Morthwest One-Quarter (1), Southeast One-Quarter (1)
Section Four (4), Town Six (6) South, Range Four (4) East, Auglaize
County and also a portion of Out Lot number One Hundred Thirty Five
(135) of St. Marys, Ohie, more particularly described as follows:

Beginning at an iron pipe marking the intersection of the South line of Edwards Street, extended, with the East line of Sturgeon Street extended southerly; thence South 0° 48' East, Six Hundred Thirty Three and Hinety Hundredths (633.90) feet along the East line of Sturgeon Street extended to a concrete marker set on the North edge of Jackson Street; thence South 88° 48' West, Four Hundred Ninety Two and Twenty Five Hundredths (492.25) feet along the Worth edge of Jackson Street to a concrete marker; thence North 1º 14: West, One Hundred Forty (140) feet to a concrete marker; thence North 79° 13' West Five Hundred Three and Fifty Hundredths (503.50) feet to a concrete marker set on the Northeast corner of the Dairy Queen property; thence North 76° 22' West, One Hundred Three and Four Hundredths (103.04) feet to a concrete marker being the Northwest corner of the Dairy Queen Lot; thence North 0° 20' West Five Hundred Seventy and Fifteen Hundredths (570.15) feet to a concrete marker set on the ene-half (a) Section line of Section Four (4) St. Marys Township; theace North 88° A81 Bast, Nine Hundred Thirty and Twenty Five Sundredtha (930.25) feet along the one-half (g) Section line to a concrete marker; thence South 0° 48' East, One Hundred Seventy Three (173) feet to a point on the center line of Edwards

Forty Hundredths (85.40) feet along center line of Edwards Street
extended to an iron pipe; thence South 0° 48' East Thirty Three (33)
feet to an iron pipe set on the South line of a 66' Edwards Street,
extended; thence North 89° 12' East, Sixty Six (66) feet along the
South line of Edwards Street extended to the point of beginning;

SECTION 2. That there are no electors residing in the above described
territory, the anaexation of which is hereby authorized and therefore the
provisions of Section 709.17 of the Revised Code of Chic, need not be
followed.

SECTION 3. That the Solicitor for the City of St. Marys, Ohio, be and

SECTION 3. That the Solicitor for the City of St. Marys. Ohio, be and he is hereby authorized to prosecute the proceedings necessary to effect such annexation.

SECTION 4. That this ordinance is an emergency ordinance. The reason for the emergency lies in the fact that the area, the subject of this ordinance, is to be subdivided into lots for residential dwellings, in the City of St. Marys, the development of which is necessary to the welfare of the citizens hereof.

SECTION 5. That this ordinance shall be in ferce and take effect immediately upon its passage.
