ORDINANCE NO. 1924

AN ORDINANCE AUTHORIZING THE VACATION OF STREETS AND ALLEYS IN THE CITY OF ST. MARYS, CHIO

WHEREAS, on the 13th day of May, 1963, a request was received by the Council for the City of St. Marys, Ohio, from the Planning Commission approving the vacation of certain streets and alleys in the City of St. Marys, Ohio, and

WHEREAS, consents have been filed with the City of St. Marys, Ohio, authorizing the vacation of the streets and alleys by the abutting property owners and waiving the notice thereof, and

WHEREAS, since all of the abutting property owners have waived service of notice, and

WHEREAS, Council upon the hearing is satisfied that there is good cause for such vacation as prayed for, and that it will not be detrimental to the general interest, it ought to be made;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL FOR THE CITY OF ST. MARYS, OHIO:

SECTION 1. That the Streets and alleys described below between the points aforesaid, be and the same are hereby vacated:

- 1. The east and west alley bounded by Lots 75 and 76 on the north, and Lot 74 on the south, in the North Addition to the City.
- 2. The east and west alley running from Indiana Avenue, bound on the north by 0. L. 133 and on the south by Lots 94 to 100 in the Motz and Dieker Addition to the City of St. Marys, Ohio, and

The northerly end of Piper Street, north of Nagel Street, bound by O. L. 133 on the west and Lot 94 of Motz and Dieker Addition on the east, in the City of St. Marys, Ohio.

- 3. The east and west alley between Lot No. 58 and Lot No. 61 in the South Addition to the City of St. Marys, Ohio.
- 4. The Herzing Street right-of-way from the easterly side of South Main Street to the easterly line of the lots of the Wm. F. Makley & Sons Subdivision in the City of St. Marys, Ohio.
- 5. Those alleys in the hospital area not previously vacated, between Knoxville Avenue, St. Clair Avenue and Hager Street.
- 6. The east and west alley bound by Lots 56 and 57 on the north, and Lots 62 and 63 on the south, in the South Addition to the City of St. Marys, Ohio.
