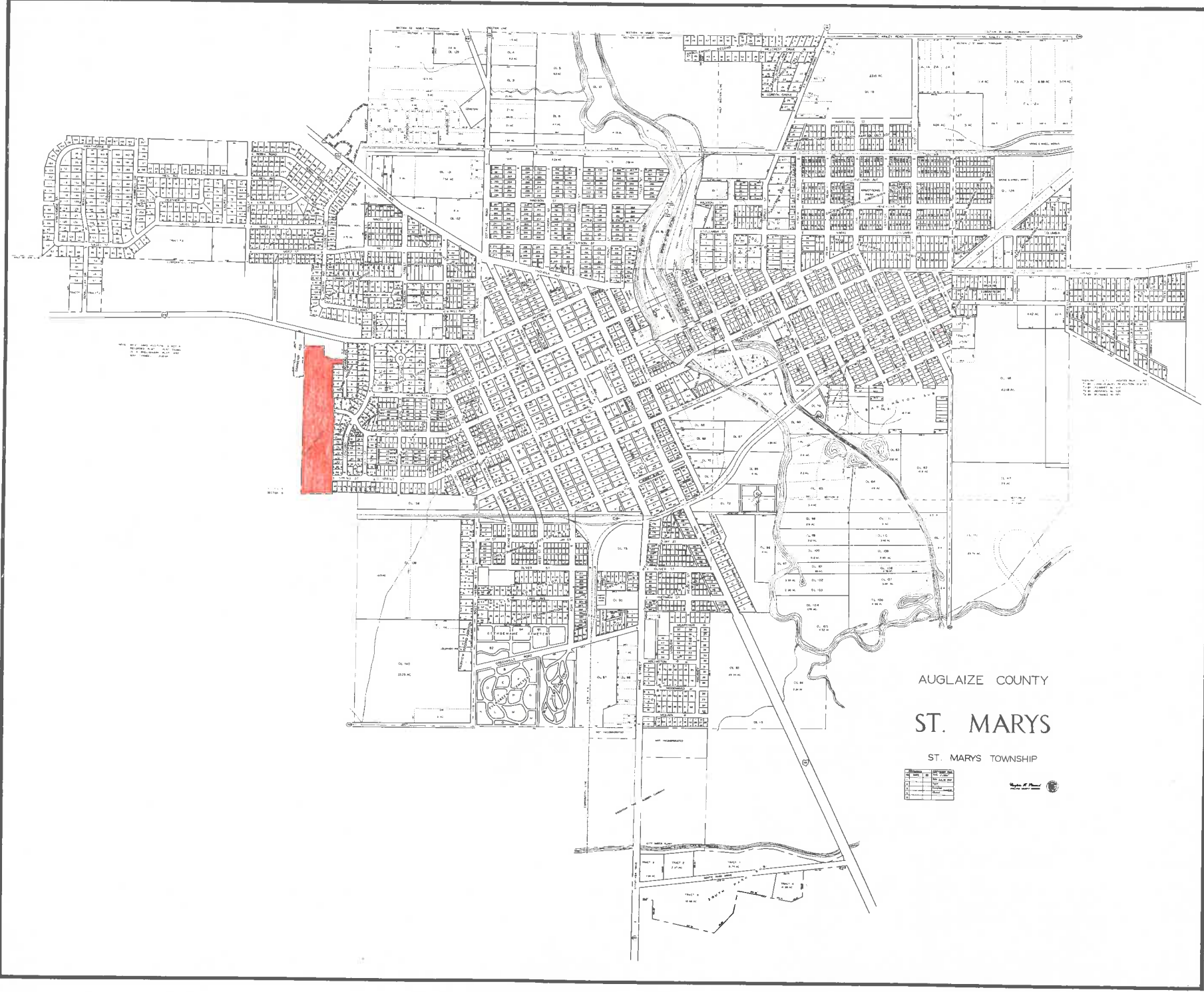

ORDINANCE NO. 1632

AN ORDINANCE AUTHORIZING THE ANNEXATION
OF CERTAIN TERRITORY TO THE CITY OF ST.
MARYS, OHIO.

BE IT ORDAINED BY THE COUNCIL FOR THE CITY OF ST. MARYS, OHIO:

SECTION 1. That the annexation of the following described territory
be made, to the City of St. Marys, Ohio:

Being a tract of land located in the Southeast Quarter of
Section 4, Town 6 South, Range 4 East, St. Marys Township, Auglaize
County, Ohio, and more particularly described as follows:

Beginning at a point on the West line of Orchard Avenue, in
the City of St. Marys, Ohio, said point of beginning being located
South 1° 15' West a distance of 211.35 feet from the intersection
of the West line of Orchard Street and the South line of State
Route #29 and North 1° 15' East a distance of 49.11 feet from an
iron pipe marking the Northeast corner of Lot 11 in the Quinby
Addition to the City of St. Marys, thence North 88° 45' West,
parallel to the North line of the said Lot 11, a distance of 106.97
feet to an iron pipe; thence North 75° 16' West a distance of 130.0
feet to an iron pipe; thence North 1° 15' East a distance of 126.19
feet to a corner post; thence North 88° 32' West a distance of 227.75
feet to a corner post; thence South 1° 15' West a distance of 1681.2
feet to a corner post; thence South 88° 14' East a distance of 355.7
feet to a corner post; thence North 1° 18' East a distance of 1089.9
feet to a corner post, said post being on the South line of Lot 16
in the Quinby Addition; thence North 89° 30' West a distance of 16.0
feet to an iron pipe on the Southwest corner of the said Lot 16; thence
North 1° 15' East along the West lines of Lots 16, 15, 14, 13, 12, 11,
in the said Quinby Addition, a distance of 387.64 feet to an iron pipe
on the Northwest corner of Lot 11; thence South 88° 45' East, along
the North line of Lot 11 a distance of 120.0 feet to an iron pipe on
the West line of Orchard Street; thence North 1° 15' East, along the
West line of Orchard Street, a distance of 49.11 feet to the place of
beginning, and containing 13.3 acres, more or less.
