The Board of County Commissioners of Auglaize County, Ohio, met in regular session on the 30th day of November, 2017.

Commissioner Regula moved the adoption of the following:

**RESOLUTION**

**WHEREAS**, pursuant to Resolution #17-456, dated November 9, 2017 the Board of County Commissioners, Auglaize County, Ohio held a public hearing in the Chambers on, November 30, 2017 at 1:00 for the purpose of vacating described platted roads within the Villa Maria Acres Subdivision, located in the W ½ of the NE ¼ Section 6, St. Marys Township, Auglaize County, Ohio as found in Plat Book B, Page 65 and Plat Book B, Page 85 in the Auglaize County Recorder's Office; and,

**WHEREAS**, proper notification was made by regular mail to all landowners abutting the road or portion of the road proposed to be vacated, notifying them of the Public Hearing date, time and place; and,

**WHEREAS**, persons present for the public hearing were Commissioners Bergman, Spencer and Regula; County Administrator Erica Preston, Clerk Esther Leffel, and Agents: Bradley Bartlett and Michael Kuck; and,

**WHEREAS**, there were no objections expressed, either verbally or written, to the petitioned vacations.

**THEREFORE BE IT RESOLVED**, after deliberation, the Board of County Commissioners, Auglaize County, Ohio, does hereby find that the the described platted streets have been abandoned and not used for a period of twenty-one years as alleged in the petition, and does hereby grant the portion of vacating the described platted streets within the Villa Maria Acres Subdivision, located in the W ½ of the NE ¼ Section 6, St. Marys Township, Auglaize County, Ohio as found in Plat Book B, Page 65 and Plat Book B, Page 85 in the Auglaize County Recorder's Office:

Streets to be vacated:

Durnell Drive from State Route 364 between lot #'s 35 and 36 of said subdivision plat; then east and south to Villa Maria Lane between Lot #'s 23 & 24.

Queen's Place from Village Maria Lane north and east between Lot #'s 24, 25, 27, 28, 29 and 30 of said subdivision.

Villa Maria Lane from SR#703 between Lot #'s 1 and 2 of said subdivision; thence north and east and thence south between Lot #'s 9 and 10 to SR #703. Legal description prepared by Douglas Reinhart, Auglaize County Engineer, PS#6507.

**BE IT FURTHER RESOLVED** that this Resolution be recorded in the office of the Auglaize County Recorder.
