We reviewed a request dated July 24, 1998, for a Letter of Map Amendment (LOMA). All required information for this request was received on July 29, 1998. Using the information submitted and the effective National Flood Insurance Program (NFIP) map, we determined that a portion of the property described below is located in the Special Flood Hazard Area (SFHA), an area that would be inundated by the flood having a 1-percent chance of being equaled or exceeded in any given year (base flood); however, the structure on the property is not in the SFHA.

Lot 6 of Southmoor Shores Subdivision, as recorded in Warranty Deed Document No. 13427, Volume 265, Pages 340 and 341, filed in the Auglaize County Recorder's Office, on February 28, 1984

This letter amends the above-referenced NFIP map to remove the structure from the SFHA. The structure is now located in Zone X (unshaded). Flood insurance coverage for the structure may be available under a low-cost policy (see enclosed document). Because portions of the property remain in the SFHA, any future construction or substantial improvement on the property remains subject to Federal, State, and local regulations for floodplain management.
