Being the northwest quarter of the northwest fractional quarter of Section 3, T-6-S, R-7-E, Clay Township, Auglaize County, Ohio as evidenced by O.R. Volume 79, Page 621 and more particularly described as follows:

Commencing for reference at a 1" iron bar (found) at the southwest corner of Section 34, T-5-S, R-7-E, Union Township, Auglaize County. thence S 89 degrees 02' 43" E along the common line of Union and Clay Townships, for a distance of 203.42 feet to a railroad spike (found) at the northwest corner of the northwest fractional quarter of Section 3, T-6-S, R-7-E, Clay Township, Auglaize County, said spike being the **POINT OF BEGINNING** for the tract herein described:

thence, S 89 degrees 04' 15" E along the north line of the northwest quarter of the northwest fractional quarter of Section 3, for a distance of 1403.05 feet to a "mag-nail" & shiner (set) over an Auglaize County Cap (found) at the northeast corner of said northwest quarter of the northwest fractional quarter, said point also being 0.35 feet left of US 33 STATION 1220+66.54 and at centerline of State Route 65 (south) STATION 277+59.75;
