PARCEL 1 LEGAL DESCRIPTION

Being part of Parcel #A03-008-005-02 described in Volume 270, Page 638 of the Auglaize County Official Record of Deeds. Situated in the SW ¼ of the NE ¼ of Section 8 and the W ½ of the SE 1/4 of Section 8, T 6 S, R 7 E, Clay Township, County of Auglaize, State of Ohio a tract of land bounded and described as follows:

Commencing at a monument box found at the northeast corner of the NW 1/4 of the SE 1/4 of said Section 8 at the intersection of the centerline of Gever Road (CR 207) and Clay Road (TR 126), also being the POINT OF BEGINNING for the tract of land herein described;

thence along the centerline of Geyer Road (CR 207) as previously defined by surveys recorded in Survey Book "F", Page 44 and Survey Book "J", Page 5 in the Auglaize County Engineer's Office, S 00°-32'-45" W a distance of 1,780.17 feet to a set PK nail, passing a railroad spike found at 857.00 feet;
