

BUSH DESCRIPTION 40.000 ACRE (EAST)

The following described tract of land is part of the Southeast and Southwest Quarters of Section 16, Town 6 South, Range 7 East, Clay Township, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at a Monument Box found at the Northeast corner of the Southwest Quarter of Section 16, Clay Township and in the centerline of Township Road 116 (Gutman Road);

Thence S.00°36'59"W. along the East line of the Southwest Quarter, a distance of 1,314.29 feet to a 5/8 inch diameter iron pin set, passing thru a 5/8 inch diameter iron pin set for reference at 20.00 feet in the South right-of-way line of Township Road 116;

Thence S.89°27'09"E. a distance of 88.85 feet to a point in the centerline of the Pusheta Permanent Maintenance Ditch, passing thru a 5/8 inch diameter iron pin set for reference at 68.85 feet in the top of the ditch bank;

Thence S.21°38'07"W. along the centerline of the Pusheta Permanent

Maintenance Ditch, a distance of 263.79 feet to a point;

Thence N.89°11'17"W. a distance of 1,103.86 feet to a 5/8 inch diameter iron pin set, passing thru a 5/8 inch diameter iron pin set for reference at 20 .00 feet in the top of the ditch bank;

Thence N.00°36'59"E. a distance of 1,560.86 feet to a Mag Nail set, passing thru a 5/8 inch diameter iron pin set for reference at 1,540.86 feet in the South right-of-way line of Township Road 116;

Thence S.89°11'17"W. along the centerline of Township Road 116 and the North line of the Southwest Quarter of Section 16, a distance of 1,109.79 feet to the Monument Box at the Northeast corner of the Southwest Quarter of Section 16, which was the true PLACE OF BEGINNING.

Containing in all 40,000 Acres of which 0.509 Acre is subject to easement for highway purposes. 0.236 Acre is located in the Southeast Quarter and 39.764 Acre is located in the Southwest Quarter of Section 16. BUSH DESCRIPTION 40.000 ACRE (SOUTH)

The following described tract of land is part of the Southwest Quarter of Section 16, part of the Northwest Quarter of Section 21, Outlot No. 12 and part of a vacated street and alley in the Village of Geyer, Town 6 South, Range 7 East, Clay Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument Box found at the Northeast corner of the Southwest Quarter of Section 16, Clay Township and in the centerline of Township Road 116

Thence N.89°11'17"W. along the North line of the Southwest Quarter of Section 16 and the centerline of Township Road 116, a distance of 2,188.38 feet to a Mag Nail

Thence S.16°18'07"E. along the Easterly right-of-way line of the Indiana and Ohio Railway Company, a distance of 1,633.15 feet to a 5/8 inch diameter iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.89°11'17"E., parallel to the North line of the Southwest Quarter of Section 16 and the centerline of Township Road 116, a distance of 1,707.19 feet to a point in the centerline of the Pusheta Permanent Maintenance Ditch, passing thru a 5/8 inch diameter iron pin set for reference at 1,687.19 feet in the top of the ditch bank;

Thence N.89°11'17"W. along the North line of the Southwest Quarter of Section 16 and the centerline of Township Road 116, a distance of 1,109.79 feet to a Mag Nail set which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.00°36'59"W., parallel to the East line of the Southwest Quarter, a distance of 1,560.86 feet to a 5/8 inch diameter iron pin set, passing thru a 5/8 inch diameter iron pin set for reference at 20.00 feet in the South right-of-way line of Township Road 116;

Thence N.89°11'17"W., parallel to the North line of the Southwest Quarter of Section 16 and the centerline of Township Road 116, a distance of 603.33 feet to a 5/8 inch diameter iron pin set;
