SURVEYOR'S DESCRIPTION Permanent Parcel #A03-021-008-02

The following described parcel of land is a part of the Northwest and Northeast Fractional Quarters of Section 21, Clay Township, and the Southwest and Southeast Quarters of Section 21, Clay Township, Town-6-South, Range-7-East, Auglaize County, Ohio, and is currently referenced as permanent parcel #A03-021-008-02. The description for this parcel shall include of two tracts of land, TRACT #1 and TRACT #2, and is more particularly described as follows:

Tract #1

Commencing for reference at a Monument Box (found) situated at the Southwest corner of the Southeast Quarter of said Section 21, Clay Township, Town-6-South, Range-7-East;

Thence with a bearing of S. 88°-52′-09" E. along the South line of the Southeast Quarter of said Section 21, Clay Township, and the legal centerline of Santa Fe-New Knoxville Road (County Road #100), for a distance of 250.54 feet to a Mag Nail (set) and the PLACE OF BEGINNING;

Thence with a bearing of N. 16°-18'-14" W. along the East line of the former Detroit - Toledo & Ironton (DT&I) Railroad, for a distance of 3,147.24 feet to an Iron Pin (set) at the Southwest corner of OutLot 9 to the Village of Geyer, Ohio, as referenced by permanent parcel #A03-212-010-00, and by Deed Volume OR 701, Page 1270, and passing thru an Iron Pin (set) at the intersection of the East line of said Railroad with the Northerly right-of-way line of said Santa Fe-New Knoxville Road, at a distance of 31.44 feet;

Thence with a bearing of S. 88°-58'-56" E. along the South line of said OutLot 9, and the Southerly corporation line of said Village of Geyer, same line being the South line of the Northwest Fractional Quarter of said Section 21, Clay Township (also known as the former Indian Treaty / Boundary Line), for a distance of 483.62 feet to a Point at the Southeast corner of said OutLot 9;

Thence with a bearing of N. 16°-18'-14" W. along the East line of said OutLot 9, and the Easterly corporation line of said Village of Geyer, for a distance of 1,036.13 feet to a ½ inch Iron Pin (found) in the legal centerline of Geyer Drive (County Road #108A), also known as Pike Street, and passing thru an Iron Pin (set) for reference at a distance of 1,011.13 feet;

Thence with a bearing of N. 74° -55'-31" E. along the legal centerline of Geyer Drive (County Road #108A), for a distance of 281.24 feet to a Mag Nail (set);

Thence with a bearing of S. 15°-04'-29" E. for a distance of 284.00 feet to a Point at the Southwest corner of a Cemetery referenced by permanent parcel #A03-021-010-00, and as referenced by Deed Volume 136, Page 298, and passing thru an Iron Pin (set) at the Northwest corner of said Cemetery at a distance of 30.00 feet, and also passing by a steel fence post (found) for reference at a distance of 262.75 feet;

Thence with a bearing of N. 74°-55'-31" E. along the South line of said Cemetery for a distance of 180.00 feet to a Point at the Southeast corner of said Cemetery;

Thence with a bearing of N. 15°-04'-29" W. along the East line of said Cemetery for a distance of 284.00 feet to a Mag Nail (set), and passing thru an Iron Pin (set) at the Northeast corner of said Cemetery at a distance of 254.00 feet, and passing by a steel fence post (found) for reference at a distance of 21.09 feet;

Thence with a bearing of N. 74°-55'-31" E. along the legal centerline of Geyer Drive (County Road #108A), for a distance of 405.18 feet to a P.K. Nail (found) at the Northwest corner of permanent parcel #A03-021-008-00 as referenced by Deed Volume OR 697, Page 1804;

Thence with a bearing of S. 00°-13'-54" W. along the West line of said permanent parcel #A03-021-008-00, for a distance of 1,645.00 feet to an Iron Pin (found), and passing thru an Iron Pin (set) for reference at a distance of 25.92 feet;

Thence with a bearing of N. 89°-46'-06" W. along a line of said permanent parcel #A03-021-008-00, for a distance of 221.00 feet to an Iron Pin (found);

Thence with a bearing of S. 00°-13'-54" W. along the West line of said permanent parcel #A03-021-008-00 for a distance of 514.75 feet to a Point;

Thence with a bearing of S. 89°-46'-06" E. along the South line of said permanent parcel #A03-021-008-00, for a distance of 269.23 feet to a Point;

Thence with a bearing of N. 00°-13'-54" E. along the East line of said permanent parcel #A03-021-008-00, for a distance of 1,946.31 feet to a Point at the Southwest corner of permanent parcel #A03-021-008-01 as referenced by Deed Volume OR 287, Page 403;

Thence with a bearing of N. 74°-55'-31" E. along the South line of said permanent parcel #A03-021-008-01, and parallel with the legal centerline of Geyer Drive (County Road #108A), for a distance of 225.00 feet to a Point at the Southeast corner of said permanent parcel #A03-021-008-01;

Thence with a bearing of N. 00°-13'-54" E. along the East line of said permanent parcel #A03-021-008-01 for a distance of 226.64 feet to a P.K. Nail (found) at the Northeast corner of said permanent parcel #A03-021-008-01, and passing thru an Iron Pin (set) for reference at a distance of 200.72 feet;

Thence with a bearing of N. 74°-55'-31" E. along the legal centerline of Geyer Drive (County Road #108A), for a distance of 751.30 feet to a Point;

Thence with a bearing of S. 00°-48'-35" W. along the West line of permanent parcel #A03-021-009-02 as referenced by Deed Volume OR 690, Page 2473, for a distance of 598.69 feet to an Iron Pin (found), and passing thru a Mag Nail (found) at a distance of 0.30 feet, and passing thru an Iron Pin (found) for reference at a distance of 26.21 feet;

Thence with a bearing of S. 88°-48'-04" E. along a line of said permanent parcel #A03-021-009-02 for a distance of 280.00 feet to an Iron Pin (found);

Thence with a bearing of S. 00°-48'-35" W. along the West line of said permanent parcel #A03-021-009-02 for a distance of 924.00 feet to an Iron Pin (found);

Thence with a bearing of N. 88°-48'-04" W. along the North line of permanent parcel #A02-213-001-01 as referenced by Deed Volume OR 481, Page 526, for a distance of 278.78 feet to a steel fence post (found) at the Northeast corner of the West half of the Southeast Quarter of said Section 21, Clay Township;

Thence with a bearing of S. 00°-49'-43" W. along the East line of the West half of the Southeast Quarter of said Section 21, Clay Township, and along the West line of permanent parcel #A02-213-001-01 as referenced by Deed Volume OR 481, Page 526, and the West line of permanent parcel #A02-213-001-00 as referenced by Deed Volume OR 410, Page 836, for a distance of 2,997.75 feet to a P.K. Nail (found) at the Southeast corner of the West half of the Southeast Quarter of said Section 21, Clay Township, and passing thru an Iron Pin (found) at a distance of 2,972.75 feet;

Thence with a bearing of N. 88°-52'-09" W. along the South line of the Southeast Quarter of said Section 21, Clay Township, and the legal centerline of Santa Fe-New Knoxville Road (County Road #100), for a distance of 1,073.27 feet to a Mag Nail (set) and the original PLACE OF BEGINNING.

TRACT #1 containing in all, 153.4956 Acres of land. The above described tract of land contains a total of 1.598 Acres previously dedicated for highway purposes, and is subject to any or all legal easements, reservations, or restrictions of record upon said premises. Tract #1 contains 7.5473 Acres situated in the Northwest Fractional Quarter, 43.6928 Acres situated in the Northeast Fractional Quarter, 17.0612 Acres situated in the Southwest Quarter, and 85.1943 Acres situated in the Southeast Quarter, all being located in Section 21, Clay Township, Town-6-South, Range-7-East.

TRACT #2

Commencing for reference at a Point situated at the intersection of the centerline of the former Detroit – Toledo & Ironton (DT&I) Railroad with the Southerly right-of-way line of Geyer Drive (County Road #108A), also known as Pike Street, in the Village of Geyer, Ohio;

Thence with a bearing of N. 74°-55'-31" E. along the Southerly right-of-way line of Geyer Drive (County Road #108A), for a distance of 775.40 feet to an Iron Pin (set) at the Northwest corner of a Cemetery referenced by permanent parcel #A03-021-010-00, and as referenced by Deed Volume 136, Page 298, and the PLACE OF BEGINNING;

Thence with a bearing of N. 15°-04'-29" W for a distance of 30.00 feet to a Mag Nail (set) in the legal centerline of Geyer Drive (County Road #108A);

Thence with a bearing of N. 74°-55'-31" E. along the legal centerline of Geyer Drive (County Road #108A), for a distance of 180.00 feet to a Mag Nail (set);

Thence with a bearing of S. 15°-04'-29" E. for a distance of 30.00 feet to an Iron Pin (set) at the Northeast corner of said Cemetery;

Thence with a bearing of S. 74°-55'-31" W. along the Southerly right-of-way line of Geyer Drive (County Road #108A), and the Northerly line of said Cemetery, for a distance of 180.00 feet to an Iron Pin (set) at the Northwest corner of said Cemetery, and the original PLACE OF BEGINNING.

TRACT #2 containing in all, 0.124 Acre of land, all of which has been previously dedicated for highway purposes, and is also subject to any or all legal easements, reservations, or restrictions of record upon said premises. Tract #2 being situated entirely in the East half of the Northwest Fractional Quarter of said Section 21, Clay Township.

TRACT #1 and TRACT #2, when combined, contains a total of 153.6196 Acres of land, with 1.722 Acres being previously dedicated for highway purposes. This parcel, in its' entirety, is subject to any or all legal easements, reservations, or restrictions of record upon said premises.

This parcel describing TRACT #1 and TRACT #2, when combined, is currently referenced as permanent parcel #A03-021-008-02

Reference is made to a plat of Geyer City as surveyed by Samuel Craig, September 20, 1893, and recorded December 26, 1893, in Plat Book 1A, page 385, and Plat Book 1B, page 385. Also, reference is made to a Plat of Incorporation of the Village of Geyer as recorded January 14th, 1901, in Plat Book 2, Page 43A, in the Auglaize County Recorder's Office.

The basis of bearings used for this description were determined from the Auglaize County Engineer's Global Positioning Survey whereas the South line of the Southeast Quarter of said Section 21, Clay Township, and the legal centerline of Santa Fe - New Knoxville Road (County Road #100), has a bearing of S. 88°-52'-09" E.

This legal description was prepared from an actual field survey performed by Ted K. Schnell, Professional Land Surveyor #7216, from December 2nd to December 11th, 2020. A survey plat of this field survey is recorded with the Auglaize County Engineer's Map Office located at Survey CLA-21-2.
