Commencing for reference at a p-k nail (found) at the southeast corner of the southwest fractional quarter of Section 27 and the centerline intersection of Southland Road and State Route 65; thence, N 00 degrees 56' 17" E along the east line of the southwest fractional quarter of Section 27 and the centerline of State Route 65, for a distance of 1645.14 feet to a mag-nail (found);

thence, N 88° 40′ 52" W (passing through a 5/8" re-rod w/cap found on the west right-of-way line of State Route 65 at a distance of 30.00 feet) for a total distance of 1208.55 feet to a 5/8" re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

Commencing for reference at a p-k nail (found) at the southeast corner of the southwest fractional quarter of Section 27 and the centerline intersection of Southland Road and State Route 65; thence, N 00 degrees 56' 17" E along the east line of the southwest fractional quarter of Section 27 and the centerline of State Route 65, for a distance of 1695.14 feet to a mag-nail (found), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, N 88 degrees 40' 52" W (passing through a 5/8" re-rod w/cap set on the west right-of-way line of State Route 65 at a distance of 30.00 feet) for a total distance of 648.00 feet to a 5/8" re-rod w/cap (found);

thence, N 00 degrees 15' 40" W for a distance of 324.68 feet to a 5/8" re-rod w/cap (found);
