LEGAL DESCRIPTION

Being a part of the southeast quarter of Section 12, Town-5-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio as evidenced by Deed Volume 247, Page 40 and more particularly described as follows:

Commencing at a monument box (found) at the southeast corner of the southeast quarter of said Section 12, and the legal centerline of Townline-Lima Road; thence, N 00 degrees 58' 00" E along the east line of the southeast quarter of Section 12 and the legal centerline of Townline-Lima Road, for a distance of 1333.36 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, N 85 degrees 45' 54" W (passing through a 5/8" re-rod w/cap set on the west right-of-way line of Townline-Lima Road at a distance of 25.04 feet) for a total distance of 443.79 feet to a 5/8" re-rod w/cap (set);

thence, N 37 degrees 22' 58" W for a distance of 160.85 feet to a 5/8" re-rod w/cap (set) below plow depth;

thence, N 89 degrees 02' 00" W for a distance of 117.48 feet to a 5/8' re-rod w/cap (set) below plow depth;

thence, N 01 degree 45' 16" E for a distance of 228.96 feet to a 5/8" re-rod w/cap (set) below plow depth;

thence, S 89 degrees 02' 00" E (passing through a 5/8" re-rod w/cap set on the west right-of-way line of Townline-Lima Road at a distance of 632.21 feet) for a total distance of 657.21 feet to a cotton gin spindle (set) on the east line of the southeast quarter of Section 12 and the legal centerline of Townline-Lima Road;

thence, S 00 degrees 58' 00" W along the aforesaid east line and centerline, for a distance of 380.39 feet to the **POINT OF BEGINNING**, containing therein 5.019 acres, of which 0.218 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M.
