SURVEYOR'S DESCRIPTION

Being a tract of land situate in the northwest quarter of Section 12, Town-5-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio as evidenced by Official Record Volume 313, Page 266 and more particularly described as follows:

Commencing for reference at a monument box (found) at the northwest corner of the east half of the northwest quarter of Section 12, and the centerline intersection of Mudsock Road and Buckland-Holden Road; thence, N 90 degrees 00' 00" E along the north line of the northwest quarter of Section 12 and the legal centerline of Buckland-Holden Road, for a distance of 494.99 feet to a cotton gin spindle (found), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid north line and legal centerline, on a bearing of N 90 degrees 00' 00" E for a distance of 474.18 feet to a cotton gin spindle (set);

thence, S 01 degree 17' 24" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Buckland-Holden Road at a distance of 25.00 feet) for a total distance of 414.47 feet to a 5/8" re-rod w/cap (set);

thence, N 90 degrees 00' 00" E for a distance of 219.40 feet to a 5/8" re-rod w/cap (set);

thence, N 01 degree 17' 24" E (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Buckland-Holden Road at a distance of 389.47 feet) for a total distance of 414.47 feet to a cotton gin spindle (set) on the north line of the northwest quarter of Section 12 and the legal centerline of Buckland-Holden Road;

thence, N 90 degrees 00' 00" E along the aforesaid north line and legal centerline, for a distance of 137.67 feet to a monument box (found) at the northeast corner of the east half of the northwest corner of Section 12;

thence, S 01 degree 17' 24" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Buckland-Holden Road at a distance of 25.00 feet) for a total distance of 1334.84 feet to a 5/8" re-rod (found);

thence, S 90 degrees 00' 00" W for a distance of 831.97 feet to a 5/8" re-rod w/cap (set);

thence, N 01 degree 19' 14" E (passing through a 5/8" re-rod found on the south right-of-way line of Buckland-Holden Road at a distance of 1309.85 feet) for a total distance of 1334.85 feet to the **POINT OF BEGINNING**, containing therein **23.390 acres**, of which 0.351 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. thence, S 01 degree 17' 24" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Buckland-Holden Road at a distance of 25.00 feet) for a total distance of 414.47 feet to a 5/8" re-rod w/cap (set);

thence, N 90 degrees 00' 00" W for a distance of 219.40 feet to a 5/8" re-rod w/cap (set);

thence, N 01 degree 17' 24" E (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Buckland-Holden Road at a distance of 389.47 feet) for a total distance of 414.47 feet to the **POINT OF BEGINNING**, containing therein **2.087 acres**, of which 0.126 acres is road right-of-way.
