Commencing for reference at a railroad spike (found) at the northwest corner of the southwest quarter of the southwest quarter of Section 15, and the centerline of Hauss Road; thence, S 00 degrees 48' 56" W along the west line of the southwest quarter of the southwest quarter and the centerline of Hauss Road, for a distance of 715.60 feet to a point which lies 1.50 feet west of a railroad spike (found); thence, S 89 degrees 18' 16" E (passing through the aforesaid railroad spike at a distance of 1.50 feet) for a total distance of 513.66 feet to a 5/8" re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

## SURVEYOR'S AFFIDAVIT

Regarding a tract of land situate in the southwest quarter of Section 15 and the northwest quarter of Section 22, T-5-S, R-6-E, Duchouquet Township, Auglaize County, Ohio:

Subsequent to the transfer of the above tract (more particularly being "Tract Two" as depicted on a plat of survey prepared by James M. Kent, PS 6792, drawing #3925 dated May 17, 2002 and evidenced by Official Record Volume\_\_\_, Page\_\_\_\_) it was discovered that the acreage amounts allotted to Section 15 and Section 22 are reversed.

The last paragraph of the description recorded in the aforesaid Official Record should read as follows:
