Thence S.00°42'48"W. along the West line of the Northwest Quarter of Section 18, a distance of 1,326.30 feet to an iron pin set at the Northwest corner of the Southwest Quarter of the Northwest Quarter of Section 18, Duchouquet Township;

Thence N.89°58'31"E. along the 1/8th Quarter line, a distance of 1,273.44 feet to an iron pin set;

Thence S.00°36'25"W. a distance of 870.42 feet to an iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.00°36'25"W. a distance of 2,125.58 feet to an iron pin found:

Thence N.89°23'35"W. a distance of 472.11 feet to a P.K. Nail found in the centerline of State Route 198, passing thru an iron pin found at 438.96 feet in the Easterly right-of-way line of State Route 198;

Thence N.24°22'34"W. along the centerline of State Route 198, a distance of 759.06 feet to a Mag Nail set;

Thence N.73°45'34"E. a distance of 121.08 feet to an iron pipe found, passing thru an iron pin found at 30.34 feet in the Easterly right-of-way line of State Route 198;

Thence N.19°31'26"W. a distance of 163.68 feet to an iron pin set;

Thence S.73°17'34"W. a distance of 134.91 feet to a Mag Nail set, passing thru an iron pin found at 104.57 feet in the Easterly right-of-way line of State Route 198;

Thence N.24°22'34"W. along the centerline of State Route 198, a distance of 404.44 feet to a Mag Nail found;

Thence N.37°13'13"E. along the centerline of the Shearer drainage ditch, a distance of 410.81 feet to a point being referenced by an iron pin at N.42°52'29"W. a distance of 52.90 feet;


Thence N.22°14'46"E. along the centerline of the Shearer drainage ditch, a distance of 353.24 feet to a point;
