

## PLACE FAMILY FARMS SURVEY

Being situated in the Southwest Quarter of Section 19 & in the Northeast Quarter of Section 30,

Town-5-South, Range-6-East

Duchouquet Township

Auglaize County, Ohio

## Tract 1

Being a part of the Southwest ¼ of Section 19 and the Northeast ¼ of Section 30, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing from a monument box with iron pin (found) at the Northwest corner of the Southwest ¼ of Section 19 and being on the centerline of Infirmary Road (CR166);

Thence with a bearing of S. 89° 43' 45" E. along the North line of the Southwest Quarter of Section 19 and the centerline of Infirmary Road, a distance of 319.54 feet to a railroad spike (found) and the PLACE OF BEGINNING;

Thence S. 00° 36' 25" W. a distance of 362.74 feet to an iron pin with cap (found), passing through an iron pin with cap (found) for reference at 25.00 feet on the South right-of-way line of Infirmary Road (CR 166);

Thence N. 89° 46′ 36″ W. at a distance of 319.64 feet to a point on the West Line of the Southwest ¼, passing through an iron pin (found) at a distance of 318.64 feet;

Thence S. 00° 37' 17" W. along the West Line of the Southwest ¼ at a distance of 2,017.54 feet to an iron pin with cap (found);

Thence S. 89° 48' 51" E. at a distance of 752.69 feet to an iron pin with cap (found);

Thence N. 00° 25' 46" E. at a distance of 374.34 feet to an iron pin (found);

Thence S. 89° 46' 08" E. at a distance of 549.75 feet to an iron pin (found);

Thence S. 00° 18' 53" W. at a distance of 350.06 feet to an iron pin with cap (found);

Thence S. 13° 35' 21" E. at a distance of 308.99 feet to an iron pin with cap (found) on the South Line of the Southwest ¼ of Section 19;

Thence S. 89° 41' 47" E. along the South Line of the Southwest ¼ of Section 19 at a distance of 1,235.12 feet to a monument box over stone (found) at the Southeast corner of the Southwest ¼ of Section 19 and also being the Northwest corner of the Northeast ¼ of Section 30;

Thence S. 89° 45' 33" E. along the South Line of the Southeast ¼ of Section 19 at a distance of 1,545.13 feet to a railroad spike (found) on the centerline of State Route 198 passing through an iron pin with cap "Auglaize County" (set) for reference at 1,510.26 feet on the West right-of-way line of State Route 198;

Thence S. 30° 23' 47" E. along the centerline of State Route 198 at a distance of 11.62 feet to a mag nail (found);

Thence N. 89° 45' 24" W. along the North Line of Grandview Estates Subdivision Number 4 at a distance of 1,551.23 feet to an iron pin with cap "Auglaize County" (set) also being the Northwest corner of the aforementioned subdivision, passing through an iron pin with cap "Auglaize County" (set) for reference at 34.87 feet on the West right-of-way line of State Route 198;

Thence N. 01° 16′ 14″ E. at a distance of 10.05 feet to a monument box over stone (found) being the Southeast corner of the Southwest ¼ of Section 19 and also being the Northwest corner of the Northeast ¼ of Section 30;

Thence N. 00° 43' 15" E. along the East Line of the Southwest ¼ of Section 19 at a distance of 1320.04 feet to an iron pin with cap "Auglaize County" (set);

Thence N. 89° 41' 47" W. at a distance of 1,220.29 feet to an iron pin with cap "Auglaize County" (set);

Thence S. 00° 44' 03" W. at a distance of 100.00 feet to an iron pin with cap "Auglaize County" (set);

Thence N. 89° 41' 47" W. at a distance of 100.00 feet to an iron pin with cap "Auglaize County" (set) on the East Line of Lot 25-E of the Sherwood Forest Subdivision;

Thence S. 00° 44′ 03″ W. along the East Line of Lot 25-E of the Sherwood Forest Subdivision, at a distance of 236.68 feet to an iron pin (found) at the Southeast corner of Lot 25-E in the aforementioned subdivision;

Thence S. 85° 25' 08" W. along the South Line of Lot 25-E at a distance of 115.52 feet to a pinch pipe (found);

Thence N. 89° 28' 09" W. along the South Line of Lot 25-D at a distance of 117.84 feet to a pinch pipe (found);

Thence S. 89° 24' 40" W. along the South Line of Lot 25-C at a distance of 115.83 feet to a point being the original Southwest corner of Lot 25-C;

Thence S. 89° 43' 13" W. along the South Line of Lot 25-B, at a distance of 61.13 feet to an iron pin with cap (found);

Thence S. 00° 16' 31" W. at a distance of 66.40 feet to an iron pin with cap (found)

Thence N. 88° 53' 26" W. at a distance of 328.19 feet to an iron pin with cap (found);

Thence N. 00° 45' 00" E. at a distance of 65.40 feet to an iron pin (found);

Thence N. 00° 31' 08" E. at a distance of 1679.12 feet to a mag nail (set) on the North Line of Southwest ¼ of Section 19 and being the centerline of Infirmary Road (CR 166) passing through an iron pin with cap "Auglaize County" (set) for reference at 1,654.12 feet on the South right-of-way line of Infirmary Road (CR 166);

Thence N. 89° 43′ 45″ W. along the North Line of the Southwest ¼ and being the centerline of Infirmary Road (CR 166) at a distance of 235.36 feet to a railroad spike (found) and being the PLACE OF BEGINNING;

The above-described parcel contains a total of 74.178 acres, more or less, of which 73.824 acres being located in Section 19 and 0.354 acres in Section 30. The parcel contains 0.143 acres of existing highway right-of-way, of which 0.135 acres being in Section 19 and 0.008 acres being in Section 30. This parcel is also subject to any additional legal highways and easements of record at the time of the survey.

Thence N. 89° 41' 47" W. at a distance of 100.00 feet to an iron pin with cap "Auglaize County" (set) on the East Line of Lot 25-E of the Sherwood Forest Subdivision;

Thence N. 89° 41' 47" W. at a distance of 1220.29 feet to an iron pin with cap "Auglaize County (set);

Thence S. 00° 44' 03" W. at a distance of 100.00 feet to an iron pin with cap "Auglaize County" (set);

Thence N. 89° 41' 47" W. at a distance of 50.00 feet to a point being the starting point of the proposed

Thence a proposed easement being centered on the following course and being a total of 30' wide:


S. 00° 44' 03" W. at a distance of 606.37' to a point;


