



SURVEYOR'S DESCRIPTION

Being a part of the southwest quarter of Section 22, Town-5-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio as evidenced by Official Record Volume 519, Page 1535, and more particularly described as follows:

Commencing for reference at an iron pipe (found) at the southwest corner of the southwest quarter of Section 22; thence, N 38° 32' 40" E for a distance of 1253.76 feet to a concrete right-of-way monument (found) 30' left of Station 30+00 of State Route 67; thence, N 56° 17' 00" E for a distance of 854.64 feet to a p-k nail (found) at a point of curve in the centerline of State Route 67; thence, along the aforesaid centerline on a curve to the left, said curve having a radius which measures 5,729.58 feet, a chord which bears N 53° 04' 00" E for a total arc length of 240.04 feet to a p-k nail (found); thence, N 51° 52' 00" E and continuing along the centerline of State Route 67, for a distance of 493.23 feet to a p-k nail (found), said nail being the POINT OF BEGINNING for the tract herein described;

thence, continuing along the aforesaid centerline N 51° 52' 00" E for a distance of 78.03 feet to a mag-nail (set);

thence, S 31° 06' 07" E (passing through a 5/8" re-rod w/cap set for reference at a distance of 31.09 feet) for a total distance of 281.32 feet to a 5/8" re-rod w/cap (set);

thence, S 52° 52' 03" W for a distance of 261.95 feet to a 5/8" re-rod w/cap (set):

thence, S 02° 23' 44" W for a distance of 261.13 feet to a 5/8" re-rod w/cap (set);

thence, N 89º 18' 03" W for a distance of 12.53 feet to a 5/8" re-rod (found) at the southeasterly corner of that tract evidenced by Official Record Volume 304, Page 379;

thence, N 02° 23' 44" E along the east line of the aforesaid tract (passing through a 5/8" re-rod found for reference at a distance of 571.51 feet) for a total distance of 612.11 feet to the POINT OF BEGINNING, containing therein 1.213 acres, of which 0.063 acres is road right-of-way. The above described property is an "add-on" tract, and does not meet requirements to be a 'stand-alone' building lot. Subject to all easements and right-of-way of record at the time of the recording of this instrument.
