BEGINNING at a mag nail (set) at the intersection of the north line of the southwest quarter of said Section 28 and the centerline of North Wood Street (Dixie Highway);

Thence, N 46° 15' 00" E along the centerline of North Wood Street for a distance

of 66.28 feet to a mag-nail (set);

Thence, S 43° 45′ 00″E (passing through a 5/8″ re-rod w/cap set on the southerly right-of-way line of North Wood Street at a distance of 40.00 feet and the north line of the southwest quarter of Section 28 at a distance of 59.75 feet) for a total distance of 400.00 feet to a 5/8″ re-rod w/cap (set);

Thence, S 46° 15' 00" W for a distance of 196.00 feet to a 5/8" re-rod w/cap

(set);

Thence, N 43° 45′ 00″ W (passing through an iron pipe found at the easterly corner of that parcel evidenced by OR Volume 122, Page 569 at a distance of 14.51 feet, and passing through a 5/8″ re-rod w/cap set on the southerly right-of-way line of North Wood Street at a distance of 360.00 feet) for a total distance of 400.00 feet to a mag-nail (set) on the centerline of North Wood Street;

Thence, N 46° 15′ 00″ E along the centerline of North Wood Street for a distance of 129.72 feet to the **POINT OF BEGINNING**, containing therein **1.800 acres**, of which 0.045 acres are in the northwest quarter , and 1.755 acres are in the southwest quarter of Section 28 and 0.180 acres is road right-of-way.
