SURVEYOR'S DESCRIPTION

scale:

Being a part of the southwest quarter of Section 29, T-5-S, R-6-E Duchouquet Township, and being a part of fraction 3, Lot 5 of Hammel's Estate, City of Wapakoneta, Auglaize County, Ohio and more particularly described as follows:

Commencing for reference at a 5/8" re-rod w/cap (found) at the intersection of the centerline of Veit Street with the west line of the southwest quarter of Section 29; thence, S 00° 41' 34" W along the aforesaid west line for a distance of 1612.60 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, S 89° 18' 26" E for a distance of 543.00 feet to a mag-nail (set);

thence, S 00° 41' 37" W for a distance of 342.69 feet to a 5/8" re-rod w/cap (set);

thence, N 86° 30' 20" E for a distance of 678.03 feet to a mag-nail (set) on the southwesterly line of Lot 723 of Roth's Addition;

thence, S 40° 05' 21" E along the projection of the aforesaid southwesterly line (passing through a 5/8" re-rod w/cap set for reference on the right bank of the Auglaize River at a distance of 37.37 feet) for a total distance of 102.37 feet to the center of the Auglaize River;

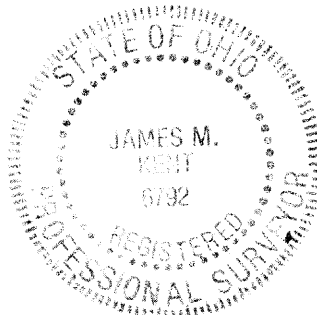
thence, S 85° 55' 03" W along the center of the Auglaize River for a distance of 745.68 feet to a point;

thence, S 84° 38' 06" W continuing downstream along the center of the Auglaize River for a distance of for a distance of 546.04 feet to a point on west line of the southwest quarter of Section 29;

thence, N 00° 41' 34" E along the aforesaid west line (passing through a mag-nail found at a distance of 73.71 feet) for a total distance of 490.40 feet to the **POINT OF BEGINNING**, containing therein **7.161 acres**. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M.
