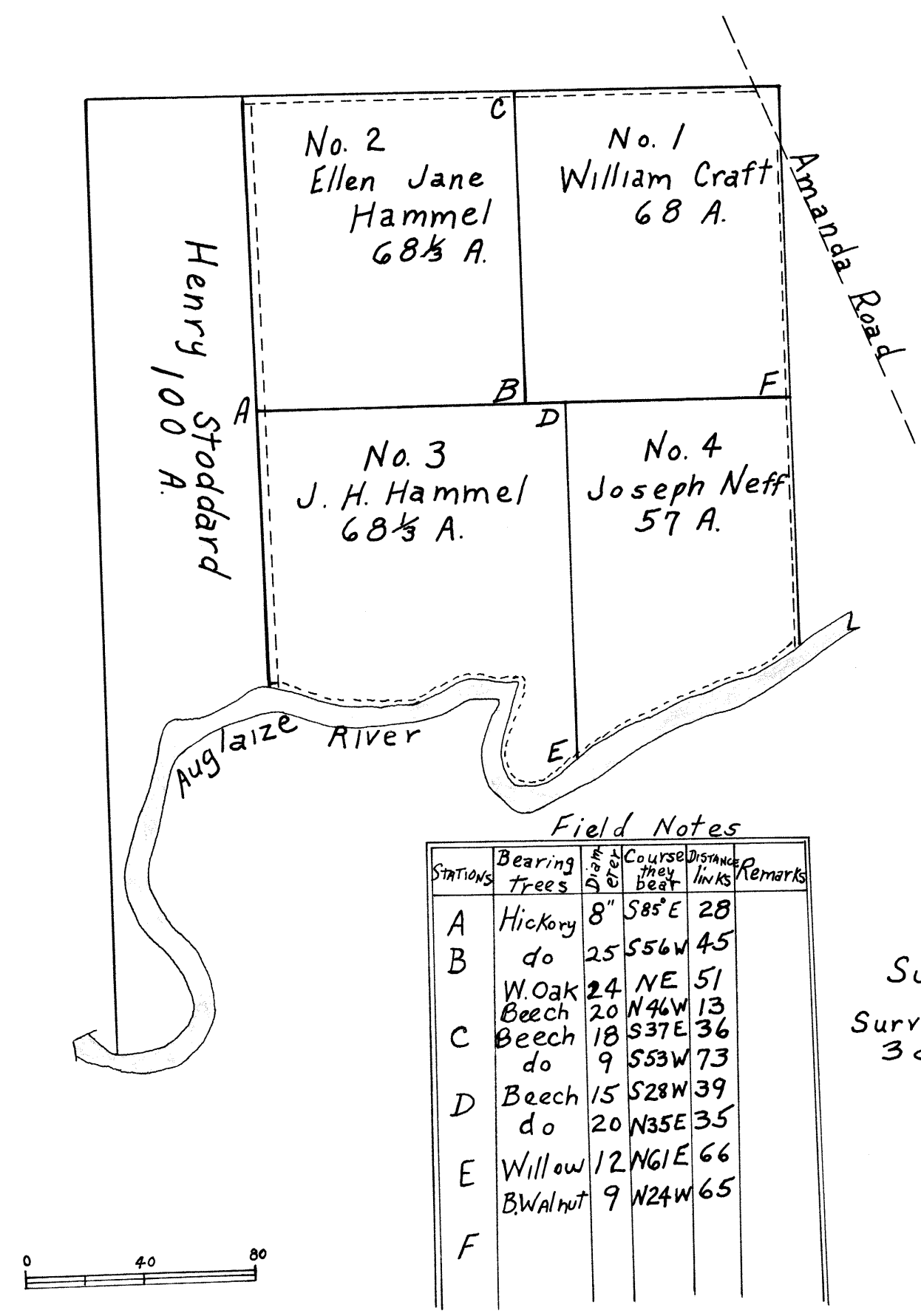

We the commissioners appointed in this cause to make partition of the following real estate that is to say that tract of land known as the Duchouquet Reservation in Town five South of Range 4 East in Section 30 in said Township accepting one hundred acres off of the West side of said tract decreed to Henry Stoddore also part of the North East fraction of Section 30 same Township containing 11 acres also the East fraction of said Section 30 containing 21 acres between the following persons that is to say Joseph Neff, William Craft, Ellen Jane Hammel and Joseph Henry Hammel and having been duly sworn upon actual view of the premises do set off and assign to the said William Craft that part marked No. 1 containing 68 acres to Ellen Jane Hammel that part marked No. 2 containing 68 acres to Joseph Henry Hammel that part marked No. 3 containing 68 1/3 and Joseph Neff that part marked No. 4 containing 57 acres all of which will more fully appear reference being had to the Platt of said land herewith returned and made part of this Report marked (A) given under our hands the 27th day of July A.D. 1850 I.
