KOENIG DESCRIPTION 44.330 ACRE

The following described tract of land is part of the Southwest Quarter of Section 30 and part of the Northwest Fraction of the Northwest Quarter of Section 31, Town 5 South, Range 6 East, Duchouquet Township, and part of the "Duchouquet Reserve", Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument Box found at the Southeast corner of the Southeast Quarter of Section 25, Moulton Township and in the centerline of Township Road 131 (Ramga Road);

Thence S.00°00'28"E. along the centerline of Township Road 131 and the West line of the Northwest Quarter of Section 31, Duchouquet Township, a distance of 137.58 feet to an iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence N.89°59'32"E. a distance of 777.53 feet to an iron pin set, passing thru an iron pin set for reference at 20.00 feet in the East right-of-way line of Township Road 131;

Thence N.00°00'28"W. a distance of 14.71 feet to an iron pin set;

The following described tract of land is part of the Southwest Quarter of Section 30 and part of the Northwest Quarter of Section 31, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at a Monument Box found at the Southeast corner of the Southeast Quarter of Section 25, Moulton Township and in the centerline of Township Road 131 (Ramga Road);

Thence N.00°56'11"E. along the centerline of Township Road 131 being the West line of the Northwest Quarter of Section 31, Duchouquet Township and the West line of the Southwest Quarter of Section 30, Duchouquet Township, a distance of 137.81 feet to a Mag Nail set, passing thru an iron pin found at 10.47 feet at the Southwest corner of Section 30, Duchouquet Township;

Thence S.89°03'49"E. a distance of 849.85 feet to an iron pin set, passing thru an iron pin set for reference at 20.00 feet in the East right-of-way line of Township Road 131;

Thence S.16°47'34"W. a distance of 257.66 feet to an iron pin set;
