



LEGAL DESCRIPTION

scale:

Being a part of the northwest quarter of Section 31, Duchouquet Township, (City of Wapakoneta), Auglaize County, Ohio as evidenced by Deed Volume 152, Page 428 and more particularly described as follows:

Commencing for reference at a stone (found) at the West Quarter Corner of Section 31; thence, N 01 degree 08' 04" W along the west line of the northwest quarter of Section 31, for a distance of 978.12 feet to a point on the centerline of County Road 33-A (said point referenced by a p-k nail found N 01 degree 08' 04" W of and 1.08 feet from said point); thence, S 81 degrees 23' 42" E for a distance of 686.90 feet to the **POINT OF BEGINNING** for the tract herein described:

thence, N 09 degrees 12' 55" E (passing through a p-k nail found at 0.66 feet, and a 5/8" re-rod w/cap found at 167.26 feet) for a total distance of 319.77 feet to the center of the Auglaize River;

thence, with the following courses along the centerline of the Auglaize River as follows:

S 70 degrees 12' 53" E for a distance of 69.01 feet to a point;

S 54 degrees 45' 08" E for a distance of 100.73 feet to a point;

S 27 degrees 28' 19" E for a distance of 53.35 feet to a point;

S 55 degrees 14' 04" E for a distance of 31.65 feet to a point;

S 37 degrees 37' 18" E for a distance of 64.24 feet to a point;

S 69 degrees 53' 07" E for a distance of 78.02 feet to a point;

S 82 degrees 53' 09" E for a distance of 63.72 feet to a point:

N 80 degrees 00' 53" E for a distance of 89.96 feet to a point;

N 62 degrees 49' 27" E for a distance of 119.62 feet to a point;

N 49 degrees 11' 41" E for a distance of 73.88 feet to a point;

thence, leaving the centerline of the Auglaize River, S 18 degrees 38' 08" E (passing through a 5/8" re-rod w/cap set for reference at a distance of 83.15 feet and a 5/8" re-rod w/cap set on the north right-of-way line of West Auglaize Street at a distance of 158.92 feet) for a total distance of 193.15 feet to a cotton gin spindle (set) on the centerline of West Auglaize Street;

thence, S 65 degrees 51' 52" W along the centerline of West Auglaize Street and CR 33-A, for a distance of 238.10 feet to a 3/4" iron bar (found) at the point of intersection of a curve (STA 438+21.26):

thence, N 81 degrees 23' 42" W along the centerline of CR 33-A, for a distance of 526.01 feet to the **POINT OF BEGINNING**, containing therein 3.288 acres, of which 0.809 acres is road right-of-way, and 0.488 acres lays within the corporate limits of Wapakoneta. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M.
