Being Lot 2 and a part of Lot 1 and 3 of Andrew Herbstreet's Addition to Section 31, T-5-S, R-6-E, Duchouquet Township, City of Wapakoneta, Auglaize County, Ohio as evidenced by Deed Volume 152, Page 147 and Deed Volume 254, Page 639 and more particularly described as follows:

Commencing for reference at a one inch diameter axle (found) at the southeast corner of Lot 1987 of the West Auglaize Street Addition Re-Plat; thence, along the north right-of-way line of West Auglaize Street, S 64° 32′ 53″ W for a distance of 328.76 feet to a 1-1/2 inch iron pipe (found) at the southeast corner of Lot 3 of Herbstreet's Addition, said pipe being the **POINT OF BEGINNING** for the parcel herein described;

thence, continuing along the aforesaid north right-of-way line S 64° 32' 53" W for a distance of 79.29 feet to a 1 inch iron pipe (found);

thence, N 87° 57' 04" E for a distance of 98.00 feet to a 5/8" re-rod w/cap (set);

thence S 02° 12′ 04″ E along the east line of Lot 1, 2 and 3 of Herbstreet's Addition for a distance of 950.30 feet to the **POINT OF BEGINNING**, containing therein **3.752 acres**.
