

Archer (Vol. 378, Page 493), South 00°02'56" West, 220.44 feet to the TRUE POINT OF BEGINNING, save and except a strip of ground 20 feet in width off the north end of the tract herein described, being immediately south of the water line of the Auglaize River, retained and reserved for street or driveway purposes, by deed recorded in Volume 99, Page 50, Deed Records of Auglaize County, Ohio.
