LEGAL DESCRIPTION

Being a part of the southeast quarter of Section 33, Town-5-South, Range-6-East, Duchouquet Township, City of Wapakoneta, County of Auglaize, State of Ohio and more particularly described as follows:

Commencing for reference at a railroad spike (found) at the intersection of the east line of the southeast quarter of said Section 33 and the centerlines of Wapak-Fisher Road and Cemetery Road; thence, N 01 degree 02' 30" E along the centerline of Cemetery Road and the east line of the southeast quarter of Section 33, for a distance of 313.98 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, N 64 degrees 38' 34" W (passing through a 5/8" re-rod w/cap set for reference at a distance of 21.95 feet) for a total distance of 239.22 feet to a point referenced by a re-rod found 0.21 feet south of and 0.28 feet east of said point;

thence, N 24 degrees 54' 00" E for a distance of 150.00 feet to a railroad spike (found);

thence, S 56 degrees 36' 00" E for a distance of 186.25 feet to a railroad "date nail" (found) on the centerline of Cemetery Road and the east line of the southeast quarter of Section 33;

thence, S 01 degree 02' 30" W along the aforesaid centerline and east line, for a distance of 136.00 feet to the **POINT OF BEGINNING**, containing therein 0.657 acres, of which 0.063 acres is road right-of-way. 

Being a part of the southeast quarter of Section 33, Town-5-South, Range-6-East, Duchouquet Township, City of Wapakoneta, County of Auglaize, State of Ohio and more particularly described as follows:

Commencing for reference at a railroad spike (found) at the intersection of the east line of the southeast quarter of said Section 33 and the centerlines of Wapak-Fisher Road and Cemetery Road; thence, N 01 degree 02' 30" E along the centerline of Cemetery Road and the east line of the southeast quarter of Section 33, for a distance of 313.98 feet to a cotton gin spindle (set); thence, N 64 degrees 38' 34" W (passing through a 5/8" re-rod w/cap set for reference at a distance of 21.95 feet) for a total distance of 239.22 feet to a point referenced by a re-rod found 0.21 feet south of and 0.28 feet east of said point; thence, N 56 degrees 36' 00" W for a distance of 210.00 feet to a railroad spike (found); thence, N 24 degrees 54' 00" E for a distance of 150.00 feet to a point; thence, N 70 degrees 33' 22" W for a distance of 127.93 feet to a 5/8" re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing N 70 degrees 33' 22" W for a distance of 79.51 feet to a railroad spike (found);

thence, S 00 degrees 00' 23" E for a distance of 20.00 feet to a 5/8" re-rod (found);

thence, N 69 degrees 58' 31" W for a distance of 142.00 feet to a 5/8" re-rod (found);

thence, N 19 degrees 02' 25" E for a distance of 148.96 feet to a 5/8" re-rod (found);

thence, S 69 degrees 55' 19" E for a distance of 140.00 feet to a 5/8" re-rod (found);

thence, S 72 degrees 21' 29" E for a distance of 81.61 feet to a 5/8" re-rod w/cap (set);

Being a part of the southeast quarter of Section 18, Town-5-South, Range-8-East, Wayne Township (Village of Waynesfield), Auglaize County, Ohio as evidenced by OR Volume 424, Page 117 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of the southeast quarter of Section 18 and the centerline intersection of SR 196 and SR 197; thence, N 00 degrees 51' 13" E along the centerline of SR 196 and the east line of the southeast quarter of Section 18, for a distance of 2499.28 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described:

thence, N 88 degrees 57' 23" W (passing through a 5/8" re-rod w/cap set on the west right-of-way line of SR 196 at a distance of 30.00 feet) for a total distance of 480.00 feet to a 5/8" re-rod w/cap (set);

thence, **N** 00 degrees 51' 13" E for a distance of 150.00 feet to a 5/8" re-rod w/cap (set) on the north line of the southeast quarter of Section 18;
