LEGAL DESCRIPTION

Being a part of the northwest quarter of Section 34, Town-4-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio as evidenced by Official Record Volume 231, Page 937 and more particularly described as follows:

Commencing for reference at a monument box (found) at the northwest corner of the northwest quarter of Section 34, and the centerline of Hauss Road; thence, S 00 degrees 44' 50" W along the west line of the northwest quarter and the centerline of Hauss Road, for a distance of 1255.72 feet to a monument box (found) at the centerline intersection of the aforesaid west line and centerline of Hauss Road with the centerline of National Road; thence, N 89 degrees 13' 39" E along the centerline of National Road, for a distance of 482.81 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the centerline of National Road, N 89 degrees 13' 39" E for a distance of 317.51 feet to a "mag" nail (set);

thence, S 00 degrees 06' 24" E (passing through a 5/8" re-rod w/cap set on the south right-of-way line of National Road at a distance of 25.00 feet) for a total distance of 470.01 feet to a 5/8" re-rod w/cap (set);

thence, N 89 degrees 16' 54" W (passing through an eight inch square concrete post at a distance of 10.65 feet) for a total distance of 315.01 feet to a 5/8" re-rod w/cap (set);

thence, N 00 degrees 25' 05" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of National Road at a distance of 436.79 feet) for a total distance of 461.79 feet to the **POINT OF BEGINNING**, containing therein 3.382 acres, of which 0.182 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M. Being a part of the northwest quarter of Section 34, Town-4-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio as evidenced by Official Record Volume 231, Page 937 and more particularly described as follows:

Commencing for reference at a monument box (found) at the northwest corner of the northwest quarter of Section 34, and the centerline of Hauss Road; thence, S 00 degrees 44' 50" W along the west line of the northwest quarter and the centerline of Hauss Road, for a distance of 1255.72 feet to a monument box (found) at the centerline intersection of the aforesaid west line and centerline of Hauss Road with the centerline of National Road, said box being the **POINT OF BEGINNING** for the tract herein described;

thence, along the centerline of National Road, N 89 degrees 13' 39" E for a distance of 428.81 feet to a cotton gin spindle (set);

thence, S 00 degrees 25' 05" E (passing through a 5/8" re-rod w/cap set on the south right-of-way line of National Road at a distance of 25.00 feet) for a total distance of 461.79 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 16' 54" E (passing through an eight inch square concrete post at a distance of 304.36 feet) for a total distance of 315.01 feet to a 5/8" re-rod w/cap (set);

thence, S 00 degrees 06' 24" E for a distance of 941.47 feet to a 5/8" re-rod w/cap (set) on the south line of the northwest quarter of Section 34;

thence, N 89 degrees 24' 11" W along the aforesaid south line, (passing through a 5/8" re-rod w/cap set on the east right-of-way line of Hauss Road at a distance of 801.07 feet) for a total distance of 821.07 feet to a "mag" nail (set) at the southwest corner of the northwest quarter of Section 34;

thence, N 00 degrees 44' 50" E along the west line of the northwest quarter and the centerline of Hauss Road, for a distance of 1392.25 feet to the **POINT OF BEGINNING**, containing therein 22.705 acres, of which 0.905 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M.
