TRACT ONE:

Being a part of the northwest quarter of Section 35, Town-4-South, Range-6-East, Duchouquet Township, Village of Cridersville, Auglaize County, Ohio, and more particularly described as follows:

Commencing at the northwest corner of the northeast quarter of the northwest quarter of Section 35; thence S 00 degrees 37' 19" W along the quarter section line (passing a chiseled "X" in concrete found at a distance of 298.05 feet) for a total distance of 461.08 feet to a 3/4" iron bar (found), said bar being the **POINT OF BEGINNING** for the tract herein described;

thence, S 01 degree 02' 41" W for a distance of 91.56 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 00' 44" W for a distance of 253.77 feet to a 5/8" re-rod w/cap (set) on the east right-of-way line of Waverly Street;

thence, N 00 degrees 00' 00" E along the east right-of-way line of Waverly Street, for a distance of 91.62 feet to a 3/4" iron bar (found);

thence N 89 degrees 02' 08" E for a distance of 255.44 feet to the **POINT OF BEGINNING**, containing therein 0.535 acres.

Being a part of the northwest quarter of Section 35, Town-4-South, Range-6-East, Duchouquet Township, Village of Cridersville, Auglaize County, Ohio, and more particularly described as follows:

Commencing at the northwest corner of the northeast quarter of the northwest quarter of Section 35; thence S 00 degrees 37' 19" W along the quarter section line for a distance of 298.05 feet to a chiseled "X: in concrete (found), said chiseled "X" being the **POINT OF BEGINNING** for the tract herein described:

thence, N 88 degrees 16' 17" E for a distance of 219.45 feet to a 1" iron pipe (found);

thence, S 00 degrees 52' 58" W for a distance of 508.20 feet to a 1" iron pipe (found);

thence, S 89 degrees 48' 48" E for a distance of 110.00 feet to a 5/8" re-rod w/cap (set);

thence, S 00 degrees 52' 37" W for a distance of 144.50 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 16' 00" W for a distance of 330.00 feet to a 5/8" re-rod w/cap (found);

thence, N 01 degree 02' 41" E (passing through a 5/8" re-rod w/cap set at a distance of 396.08 feet) for a total distance of 487.64 feet to a 3/4" iron bar (found);

thence, N 00 degrees 37' 19" E for a distance of 163.03 feet to the **POINT OF BEGINNING**, containing therein 3.649 acres. Subject to any and all interest that the Village of Cridersville may have in a strip of land abutting the south line of the subject tract, said strip measuring 15.87 feet wide (north & south) at the extreme east end of the subject tract and 16.01 feet wide (north & south) at the extreme west end of the subject tract, said strip containing 0.121 acres and is evidenced by OR Volume 120, Page 129.
