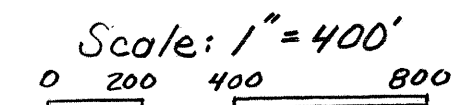
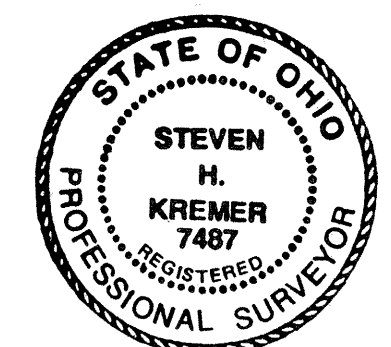

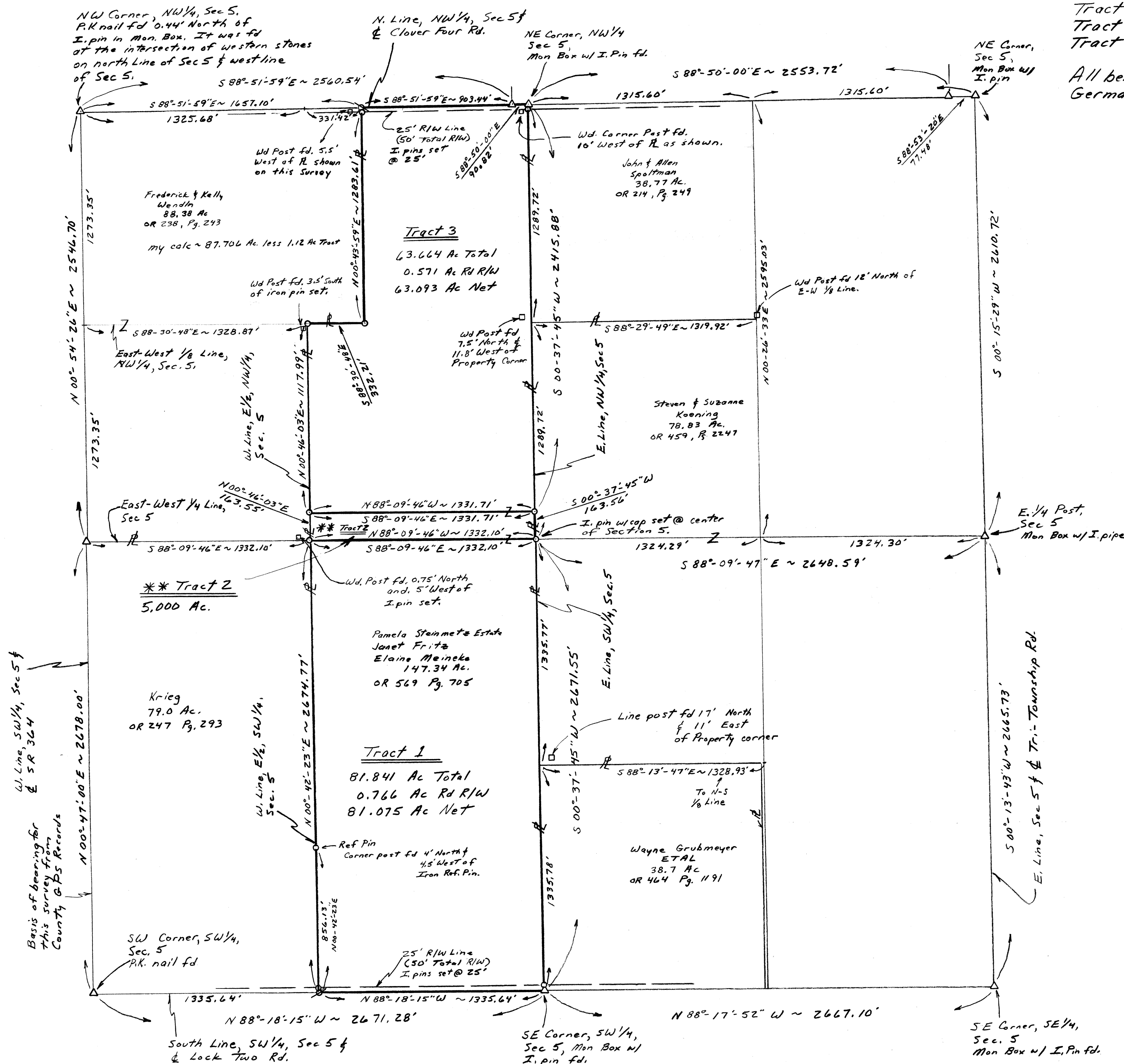


- Iron pin w/ cap set

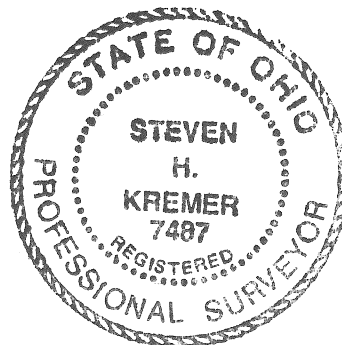

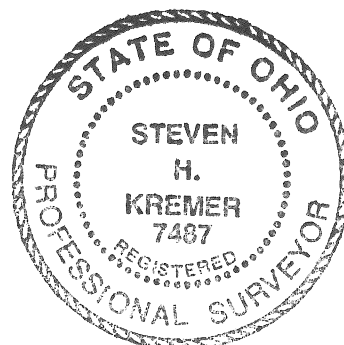
