## Kuenning\Crown Control Inc. Survey TRACT 1 48.809 ACRE

SITUATE IN THE NORTHWEST QUARTER OF SECTION 11, AND THE NORTHEAST QUARTER OF SECTION 10, TOWN 7S, RANGE 4E GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, BEING ALL THOSE LANDS OWNED BY THOMAS E. KUENNING, JR. AND SHELLEY L. KUENNING (TRUSTEES) AS RECORDED IN OFFICIAL RECORD 499 PAGE 1077 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning for reference at an iron pin found in a monument box at the northwest corner of the northwest quarter of said Section 11, and at the intersection of the centerlines of Lock Two Road and New Bremen-New Knoxville Road, said iron pin also marking the **Point of Beginning** of the tract herein described;

Thence, North 88° 20'42" East, with the north line of the northwest quarter of said Section 11 and the centerline of Lock Two Road, 312.00 feet to a Mag Nail set in the east line of a 1.000 acre tract owned by S. Howell as recorded in Official Record 134 Page 725, said Mag Nail also marking the **True Point of Beginning** of the tract herein described;

Thence, North 88°20'42" East, with the north line of the northwest quarter of said Section 11 and the centerline of Lock Two Road, 1255.67 feet to a Mag Nail set in the west line of a 2.620 acre tract owned by C & D Lesher (trustees) as recorded in Deed Volume 257, Page 156;

Thence, South 01°54'18" East, with the west line of said 2.620 acre tract, 502.92 feet to an iron pin set, passing for reference at 25.00 feet an iron pin set in the south right-of-way line of Lock Two Road;

Thence, North 88°25'48" East, with the south line of said 2.620 acre tract and the south line of a 1.420 acre tract owned by L & R Schwartz as recorded in Deed Volume 184 Page 742, 312.29 feet to an iron pin set in the west line of the Miami and Erie Canal;

Thence, South 23°20'49" West, with the west line of said Miami and Erie Canal, 623.80 feet to an iron pin set, witness at South 87°48'38" East, 16.50 feet, a canal monument found (Sta 6328+22.00 canal transit line);

Thence, South 25°36'23" West, with the west line of said Miami and Erie Canal, 305.80 feet to an iron pin with a Schnell cap found in the north line of a 17.570 acre tract owned by Crown Control Inc. as recorded in Official Record 410 Page 633;

Thence, North 00°48'27" West, with said section line 204.61 feet to a Mag Nail set, in the south line of a 1.383 acre tract owned by R & D Greber as recorded in Official Record 513, Page 1418, witness at South 88°20'10" West, 8.98 feet a P.K. nail found;

Thence, North 88°20'10" East, with the south line of said 1.383 acre tract, 341.86 feet to the center line of Wierth Ditch, passing for reference at 16.03 feet and 321.57 feet, iron pins with Marbaugh cap found and also passing at 21.04 feet the east right-of-way line of New Bremen-New Knoxville Road;

Thence, North 03°48'24" West with the centerline of Wierth Ditch and the east line of said 1.383 acre tract, 175.02 feet;

Thence, South 88°20'10" West, 26.23 feet, to the east line of a 1.004 acre tract owned by N & M Homan as recorded in Official Record 222, Page 950, passing for reference at 20.71 feet an iron pin with Marbaugh cap found;

Thence, North 00°19'22" East, with the east line of said 1.000 acre tract and aforesaid 1.000 acre tract owned by S Howell, 280.02 feet, to the **True Point of Beginning**, passing for reference at 255.01 feet the south right-of-way line of Lock Two Road, witnessing at South 22°28'37" East, 26.75 feet an iron pin set. 
