Real Estate situated in German Township, Auglaize County, State of Ohio and bounded and described as follows:

Tract 1:

Tract being a part of the southeast quarter of the southwest quarter of Section 12, Town 7 South, Range 4 East, commencing at a Mag nail at the southeast corner of the southwest quarter of said Section 12; thence North 87° 46' 00" West 20.00 feet along the south line of the southwest quarter of said Section 12 and centerline of State Route 274 to a Mag nail for the true point of beginning;

thence continuing North 87° 46' 00" West 273.45 feet along the south line of the southwest quarter of said Section 12 and centerline of State Route 274 to a Magnail;

thence North 32° 49' 41" West 145.17 feet along the approximate centerline of an un-named open ditch to a point, reference an iron pin North 76° 39' 57" East 22.00 feet;

thence North 07° 07' 42" West 461.90 feet along the approximate centerline of the sinuous, un-named open ditch to an "X" chiseled on top of an old concrete bridge abutment on the east side of the open ditch;

thence South 87° 36' 05" East 1292.70 feet along the north line of the southeast quarter of the southwest quarter of said Section 12 to an iron pin, passing thru an iron reference pin at 1.40 feet;

thence South 00° 16' 43" West 1335.23 feet, parallel to the east line of the southwest quarter of said Section 12 to the point of beginning containing 23.343 acres of land more or less of which 0.195 acre has been dedicated for highway purposes.

Tract being a part of the east half of the southeast quarter of the northeast quarter of the southwest quarter of Section 12, Town 7 South, Range 4 East, commencing at a Mag nail at the southeast corner of the southwest quarter of said Section 12; thence North 00° 16' 43" East 1335.17 feet along the east line of the southwest quarter of said Section 12 to a point; thence North 87° 36' 05" West 20.00 feet along the south line of the southeast quarter of the northeast quarter of the southwest quarter of said Section 12 to an iron pin for the true point of beginning;

thence continuing North 87° 36' 05" West 308.17 feet along the south line of the southeast quarter of the northeast quarter of the southwest quarter of said Section 12 to an iron pin;
