Commencing for reference at a one-inch iron pin found in a monument box marking the southwest corner of the Northwest Quarter of Section 5 and the centerline of County Road 261 (Waynesfield Road) -

Thence North 00°-00'-30" West (bearing base) on and along the west line of said Northwest Quarter and the centerline of said County Road 261 for a distance of 210.44 feet to a railroad spike found marking the PRINCIPAL POINT OF BEGINNING for the parcel to be described by this instrument -

Thence continuing North 00° - 00° - 30° West on and along said west line and said centerline for a distance of 401.87 feet to a PK nail set -

Thence North 89°-52'-00" East for a distance of 579.50 feet to a 5/8-inch iron pin set, passing at 25.00 feet a 5/8-inch iron pin set -

Thence South 00°-00'-30" East for a distance of 203.80 feet to a 5/8-inch iron pin set -

Thence North 89°-52'-00" East for a distance of 744.25 feet to a 5/8-inch iron pin set on the east line of the Southwest Quarter of the Northwest Quarter of said Section 5 -

Thence South 00°-00'-30" East on and along said east line for a distance of 408.51 feet to a 5/8-inch iron pin set at the southeast corner of said Southwest Quarter of the Northwest Quarter -

Thence South 89°-52'-00" West on and along the south line of said Northwest Quarter for a distance of 1091.75 feet to an iron pin with "Jauert PS 6920" cap found -

Thence North 00° - 00° - 30° West for a distance of 210.44 feet to an iron pin with "Jauert PS 6920" cap found -
