

EXHIBIT A LEGAL DESCRIPTION TRACT 1 – 51.941 ACRES

BEING PART OF E1402300603, A 81.584-ACRE TRACT OF LAND OWNED BY JON H. WOEHRMYER AND SANDRA L. Commencing for reference at a monument box with iron pin found at the southwest corner of the southwest quarter of Section 23 and being the intersection of the centerlines of Bensman Road and State Route 66;

thence, South 89°-42'-28" East, 1449.17 feet, along the south line of said Riethman Farms tract to an iron pin with cap set;

thence, North 89°-09'-33" West, 1779.73 feet, along a new division line to the principal place of beginning, passing for reference an iron pin with cap set at 1700.99.

Beginning at a monument box with iron pin found at the southwest corner of the southwest quarter of Section 23 and being the intersection of the centerlines of Bensman Road and State Route 66;

thence, South 89°-52'-42" East, 491.17 feet, along the south line of said Riethman Farms tract to an iron pin with cap set on the east line of the southwest quarter of Section 23;
