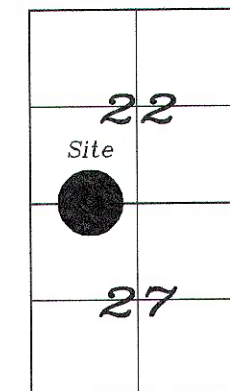


LAKE AMANDA & PLACE SURVEY

LOCATION PLAN

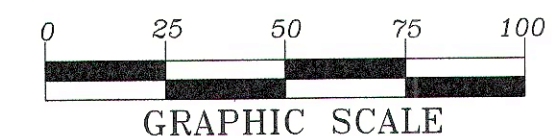

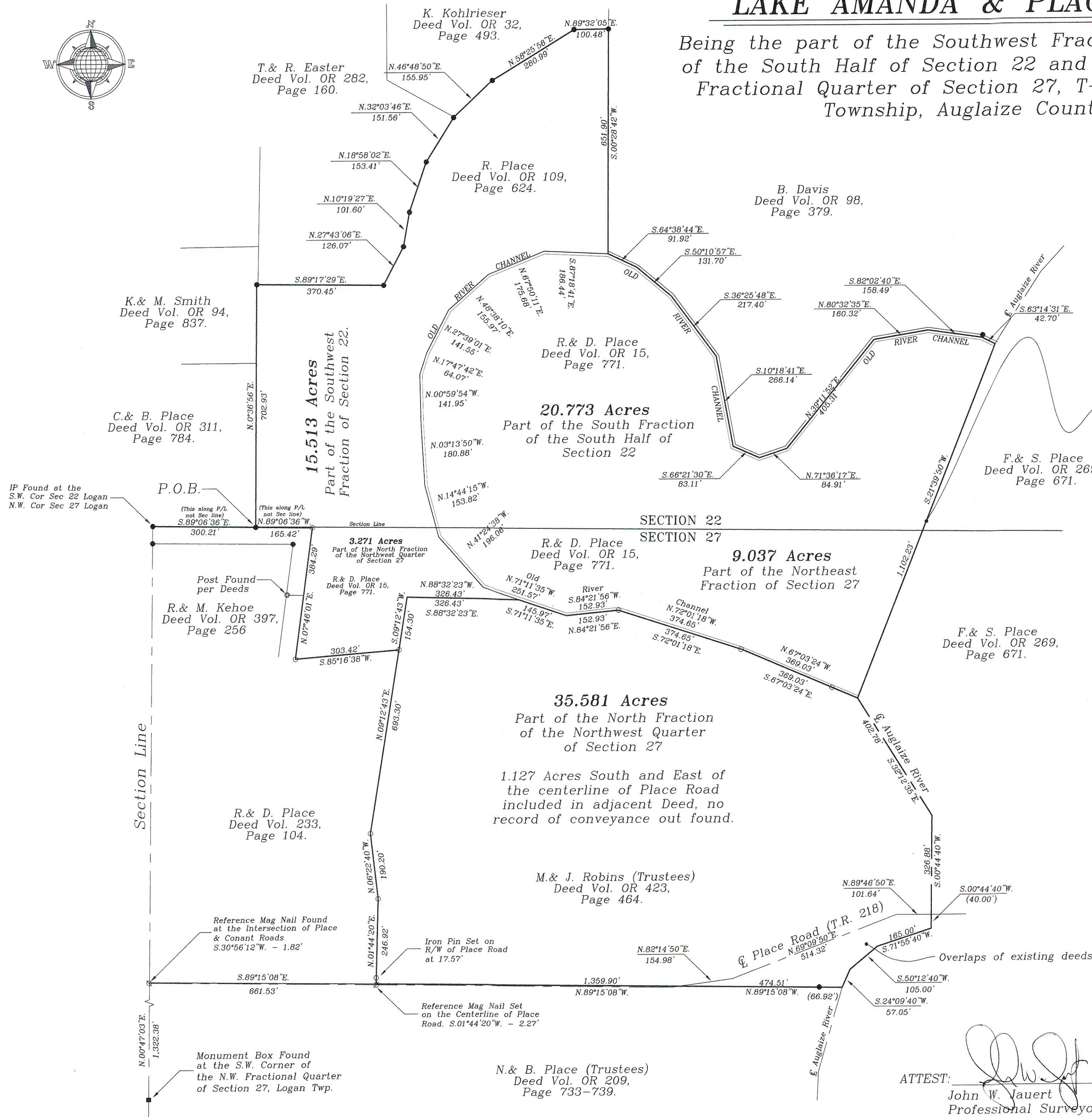


