

SURVEYOR'S DESCRIPTION

Being a part of the southwest quarter of Section 14, and a part of the southeast quarter of Section 15, Town-5-South, Range-5-East, Moulton Township, Auglaize County, Ohio as evidenced by Official Record Volume 172, Page 516 and more particularly described as follows:

Commencing for reference at a railroad spike (found) at the northeast corner of the northwest quarter of the southwest quarter of Section 14 and the legal centerline of Kelly Road; thence, S 89° 30′ 00″ W along the north line of said southwest quarter for a distance of 248.00 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

Thence, S 00° 41′ 20″ E (passing through a 5/8″ re-rod w/cap set on the south right-of-way line of Kelly Road at a distance of 20.00 feet) for a total distance of 447.18 feet to a 5/8″ re-rod w/cap (set);

Thence, S 50° 18′ 40″ W for a distance of 681.03 feet to a 5/8″ re-rod w/cap (found);

Thence, N 60° 21′ 53″ W (passing into Section 15 at a distance of 641.3 feet +/-) for a total distance of 809.19 feet to a 5/8″ re-rod w/cap (found);

Thence, N 17° 16′ 38″ E for a distance of 494.89 feet to a stone (found) at the northwest corner of the southwest quarter of Section 14 and the legal centerline of Kelly Road;

Thence, N 89° 30′ 00″ E along the north line of the southwest quarter and the legal centerline of Kelly Road for a distance of 1075.10 feet to the **POINT OF BEGINNING**, containing therein **18.036 acres**, of which 0.495 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per "Eula Doering Survey" performed by John W. SURVEYOR'S DESCRIPTION

Being a part of the southwest quarter of Section 14, and a part of the southeast quarter of Section 15, Town-5-South, Range-5-East, Moulton Township, Auglaize County, Ohio as evidenced by Official Record Volume 172, Page 516 and more particularly described as follows:

Commencing for reference at a railroad spike (found) at the northeast corner of the northwest quarter of the southwest quarter of Section 14 and the legal centerline of Kelly Road; thence, S 89° 30′ 00″ W along the north line of said southwest quarter for a distance of 20.00 feet to a railroad spike (found), said spike being the **POINT OF BEGINNING** for the tract herein described;

Thence, S 00° 41′ 20″ E (passing through a 5/8″ re-rod w/cap found on the south right-of-way line of Kelly Road at a distance of 20.00 feet) for a total distance of 361.55 feet to a 5/8″ re-rod w/cap (found);

Thence, S 85° 26′ 44″ W for a distance of 134.70 feet to a 5/8″ re-rod w/cap (found);

Thence, S 50° 18′ 40″ W for a distance of 120.45 feet to a 5/8″ re-rod w/cap (set);

Thence, N 00° 41′ 20″ W (passing through a 5/8″ re-rod w/cap set on the south right-of-way of Kelly Road at a distance of 427.18 feet) for a total distance of 447.18 feet to a mag-nail (set) on the north line of the southwest quarter and the legal centerline of Kelly Road;

Thence, N 89° 20′ 00″ E along the north line of the southwest quarter and the legal centerline of Kelly Road for a distance of 228.00 feet to the **POINT OF BEGINNING**, containing therein **2.009 acres**, of which 0.105 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per "Eula Doering Survey" performed by John W.
