



## LEGAL DESCRIPTION

scale:

Being a part of the northwest quarter of Section 16, T-5-S, R-5-E, Moulton Township, Auglaize County, Ohio as evidenced by Official Record Volume 258, Page 196 and more particularly described as follows:


Commencing at a p-k nail (found) at the northwest corner of the southwest quarter of the northwest quarter of said Section 16 and the centerline of Moulton Ft. Amanda Road; thence, S 01 degree 06' 17" W along the west line of the southwest quarter of the northwest quarter of Section 16 for a distance of 530.05 feet to a cotton gin spindle (set), said point being the **POINT OF BEGINNING** for the tract herein described;

thence, S 89 degrees 13' 41" E (passsing through a 1" iron pipe found on the east right-of-way of Moulton-Ft. Amanda Road at a distance of 25.00 feet) for a total distance of 217.38 feet to a 5/8" re-rod w/cap (found);

thence, S 01 degrees 05' 47" W for a distance of 309.28 feet to a 5/8" re-rod w/cap (found);

thence, N 89 degrees 32' 19" W (passing through a 5/8' re-rod w/cap (found) on the east right-of-way line of Moulton-Ft. Amanda Road at a distance of 192.43 feet) for a total distance of 217.43 feet to a cotton gin spindle (set) on the west line of the northwest quarter of Section 16 and the centerline of Moulton-Ft. Amanda Road;

thence, N 01 degree 06' 17" E along the aforesaid west line and centerline for a distance of 310.45 feet to the **POINT OF BEGINNING**, containing therein 1.546 acres, of which 0.178 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M. Being a part of the northwest quarter of Section 16, T-5-S, R-5-E, Moulton Township, Auglaize County, Ohio as evidenced by Official Record Volume 258, Page 196 and more particularly described as follows:

Commencing at a p-k nail (found) at the northwest corner of the southwest quarter of the northwest quarter of said Section 16 and the centerline of Moulton Ft. Amanda Road; thence, S 89 degrees 25' 24" E along the north line of the southwest quarter of the northwest quarter of Section 16 (passing through a 5/8" re-rod w/cap found at a distance of 259.55 feet) for a total distance of 260.00 feet to the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid north line, S 89 degrees 25' 24" E for a distance of 1058.97 feet to a 5/8" re-rod w/cap (set) at the northeast corner of the southwest quarter of the northwest quarter of Section 16;

thence, S 00 degrees 58' 48" W along the east line of the southwest quarter of the northwest quarter of Section 16 (passing through a 5/8" re-rod w/cap set on the north right-of-way line of Kelly Road at a distance of 1290.48 feet) for a total distance of 1320.48 feet to a cotton gin spindle set at the southeast corner of the southwest quarter of the northwest quarter of Section 16 and the centerline of Kelly Road;

thence, N 89 degrees 32' 08" W along the south line of the southwest quarter of the northwest quarter of Section 16 and the centerline of Kelly Road, for a distance of 1104.36 feet to a "mag" nail (set);

thence, N 01 degree 05' 47" E (passing through a 5/8" re-rod w/cap (set) on the north right-of-way line of Kelly Road at a distance of 30.00 feet) for a total distance of 791.87 feet to a 5/8" re-rod w/cap (found);

thence, S 89 degrees 13' 41" E for a distance of 42.61 feet to a 1" iron pipe (found):

thence, N 01 degree 06' 18" E for a distance of 530.94 feet to the **POINT OF BEGINNING**, containing therein 32.943 acres, of which 0.633 acres is road right-of-way.
